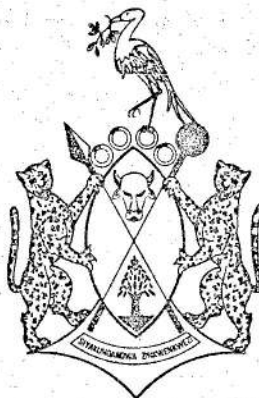

The following Government Notice is published for general information:

## TERRITORIAL WATERS ACT, 1986 (ACT 12 OF 1986) : CORRECTION

The text of the Territorial Waters Act, 1986 published in Government Gazette No. 78 of 25 July 1986 is hereby corrected –

- (1) by the substitution in subsection (3) of section 3 for the words "emigration and health" of the words "emigration, immigration and health";
- (2) by the substitution in Part 1 of Schedule 2, in the definition of the area comprising Ciskei –
  - (a) for the word "whereof" of the word "thereof"; and
  - (b) for the words "objects of that Act" of the words "the objects of that Act"; and
- (3) – by the substitution in Part 2 of Schedule 2 for the expression "Act 57 of 1963" of the expression "Act 87 of 1963".
