PUBLICATIONS OR OBJECTS**

A Committee referred to in section 4 of the Publications Act, 1974 (the Act), has decided under section 11 (2) of the Act that the undermentioned publications or objects are undesirable within the meaning of section 47 (2) of the Act.

Except under the authority of a permit issued under section 12 (2), the importation of publications published by the undermentioned publisher has already been prohibited in terms of section 9 (4) of the Publications Act:
