No. R. 290 18 Februarie 1988

WYSIGING VAN DIE REGULASIES VIR DIE SUID-AFRIKAANSE POLISIE

Die Minister van Wet en Orde het kragtens artikel 33 van die Polisiewet, 1958 (Wet 7 van 1958), die regulasies vervat in die Bylae hiervan, uitgevaardig.

BYLAE

1. In hierdie regulasies beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing R. 203 van 14 Februarie 1964, soos gewysig.

2. Regulasie 30 van die Regulasies word hierby gewysig deur paragraaf (c) na paragraaf (b) van subregulasie (4) in te voeg:

"(c) die Kommissaris, ondanks die bepalings van hierdie subregulasie, na sy oordeel goedkeuring kan verleen dat die kind van 'n vroulike lid in ander uitsonderlike omstandighede as dié genoem in hierdie subregulasie, as 'n afhanklike kind beskou kan word."

AMENDMENT OF THE REGULATIONS FOR THE SOUTH AFRICAN POLICE

The Minister of Law and Order has, in terms of section 33 of the Police Act, 1958 (Act 7 of 1958), made the regulations contained in the Schedule hereto.

SCHEDULE

1. In these regulations "the Regulations" means the regulations promulgated by Government Notice R. 203 of 14 February 1964, as amended.

2. Regulation 30 of the Regulations is hereby amended by the insertion of paragraph (c) after paragraph (b) of subregulation (4):

"(c) the Commissioner may, notwithstanding the stipulations of this subregulation, in his discretion give approval in exceptional circumstances other than those mentioned in this subregulation for the child of a female member to be regarded as a dependent child."

AMENDMENT OF THE REGULATIONS FOR THE SOUTH AFRICAN POLICE

The Minister of Law and Order has, under section 33 of the Police Act, 1958 (Act 7 of 1958), made the regulations contained in the Schedule hereto.

SCHEDULE

1. In these regulations, unless the context otherwise indicates, the expression "the Regulations" means the regulations published by Government Notice R. 203 of 14 February 1964, as amended by Government Notices R. 389 of 20 March 1964, R. 562 of 5 April 1968, R. 212 of 19 February 1971 and R. 211 of 4 February 1983.

2. Regulasie 48 van die Regulasies word hierby gewysig deur subparagraaf (ix) van paragraaf (b) van subregulasie (2) deur die volgende subparagraaf te vervang:

“(ix) ’n statutêre instelling wat spesifiek deur ’n wet van die Parlement ingestel is en sy fondse in die geheel of gedeeltelik direk uit die Staatsinkomstefonds verkry, ongeag of dit deur ’n Staatsdepartement beheer word of nie; of”.

3. Regulasie 50 van die Regulasies word hierby gewysig deur subregulasie (4) deur die volgende subregulasie te vervang:

“(4) Aan ’n lid wat minstens 10 jaar ononderbroke diens voltooi het en wat weens langdurige siekte al die siekteverlof met volle betaling opgebruik het wat kragtens regulasie 45 (1) (b) aan hom verleen kan word, kan behoudens die bepalings van regulasie 51 addisionele siekteverlof met volle betaling verleen word in dié mate en op voorwaardes wat die Kommissaris, op aanbeveling van die Kommissie vir Administrasie en met die goedkeuring van die Tesourie, mag bepaal.”.

2. Regulation 48 of the Regulations is hereby amended by the substitution for subparagraph (ix) of paragraph (b) of subregulation (2) of the following subregulation:

“(ix) a statutory institution that was specifically established by an Act of Parliament and which obtains its funds wholly or partially direct from the State Revenue Fund, irrespective of whether or not it is controlled by a Government Department; or”.

3. Regulation 50 of the Regulations is hereby amended by the substitution for subregulation (4) of the following subregulation:

“(4) A member who has completed at least 10 years' continuous service and who, on account of prolonged illness, has taken all the sick leave with full pay which may be granted to him in terms of regulation 45 (1) (b), may, subject to the provisions of regulation 51, be granted additional sick leave with full pay to such an extent and subject to such conditions as the Commissioner may determine on the recommendation of the Commission for Administration and with the approval of the Treasury.”.
