The Deputy Minister of Economic Affairs and Technology, Dr T. G. Alant, MP, has appointed an *ad hoc* committee to review the laws relating to immaterial property in South Africa and if necessary to recommend improvements thereof. Judge L. T. C. Harms is the chairman of the committee. The other members are Professor E. D. du Plessis and Mr A. P. Geyser. Dr Alant has commissioned the committee to dispose of the task as soon as possible.

The first two laws which will be reviewed are—

- (i) The Trade Marks Act, 1963 (Act 62 of 1963); and
- (ii) The Designs Act, 1967 (Act 57 of 1967).
