BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

Appropriation of amounts of money for requirements of Administration: House of Representatives

- 5 1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1989, the amounts of money shown in column 1 of the Schedule, with which the Revenue Account: House of Representatives shall be charged.
