Wet No. 84, 1988 WYSIGINGSWET OP PLAASLIKE OWERHEIDSOPLEIDING, 1988

WET

Tot wysiging van die Wet op Plaaslike Owerheidsopleiding, 1985, ten einde "plaaslike owerheidsliggaam" nader te omskryf; te bepaal dat die provinsiale sekretaris van elke provinsie 'n lid van die Opleidingsraad is; en voorsiening te maak dat sekere geld slegs aangewend kan word vir die bestryding van uitgawes wat voortspruit uit die voorsiening van opleiding deur die Opleidingsraad goedgekeur; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 41 van 1985

1. Artikel 1 van die Wet op Plaaslike Owerheidsopleiding, 1985 (hieronder die Hoofwet genoem), word hierby gewysig deur die omskrywing van "plaaslike owerheidsliggaam" deur die volgende omskrywing te vervang:
 - "plaaslike owerheidsliggaam" 'n liggaam, raad of instelling beoog in artikel 84 (1) (f) van die Wet op Proviniale Bestuur, 1961 (Wet No. 32 van 1961), en ook—
 - (a) 'n Kleurling- en Indiërs- raadplegende buurtsake- en bestuurskomitee;
 - (b) ['n instelling of liggaam ingestel kragtens die Wet op Landelike Kleurlinggebiede, 1979 (Wet No. 1 van 1979), van die Verteenwoordigende Kleurlingraad van die Republiek van Suid-Afrika] 'n bestuursraad of raad bedoel in artikel 1 van die Wet op Landelike Gebiede (Raad van Verteenwoordigers), 1987 (Wet No. 9 van 1987);
 - (c) ['n gemeenskapsraad ingestel kragtens die Wet op Gemeenskapsrade, 1977 (Wet No. 125 van 1977)] 'n plaaslike bestuursliggaam ingestel uit hoofde van die bepalings van artikel 30 (2) (a) van die Swart Administrasie Wet, 1927 (Wet No. 38 van 1927);
 - (d) 'n plaaslike [bestuur] owerheid soos omskryf in die Wet op Swart Plaaslike [Besture] Owerhede, 1982 (Wet No. 102 van 1982);
 - (e) 'n streeksdiensteraad ingestel kragtens artikel 3 van die Wet op Streeksdiensterade, 1985 (Wet No. 109 van 1985); of
 - (f) 'n liggaam of instelling wat kragtens subartikel (2) tot 'n plaaslike owerheidsliggaam vir die doeleindes van hierdie Wet verklaar word.".

LOCAL GOVERNMENT TRAINING AMENDMENT ACT, 1988

Act No. 84, 1988

ACT

To amend the Local Government Training Act, 1985, so as to further define "local government body"; to provide that the provincial secretary of every province shall be a member of the Training Board; and to provide that certain moneys may only be utilized to defray expenditure arising from the provision of training approved by the Training Board; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 41 of 1985

1. Section 1 of the Local Government Training Act, 1985 (hereinafter referred to as the principal Act), is hereby amended by the substitution for the definition of "local government body" of the following definition:

"local government body" means a body, council or institution intended in section 84 (1) (f) of the Provincial Government Act, 1961 (Act No. 32 of 1961), and includes—

- 10 (a) a Coloured and Indian consultative, local affairs and management committee;
- (b) **[an institution or body established under the Coloured Land Areas Law, 1979 (Law No. 1 of 1979), of the Coloured Persons Representative Council of the Republic of South Africa]** a board of management or board referred to in section 1 of the Rural Areas Act (House of Representatives), 1987 (Act No. 9 of 1987);
- 15 (c) **[a community council established under the Community Councils Act, 1977 (Act No. 125 of 1977)]** any local government body established by virtue of the provisions of section 30 (2) (a) of the Black Administration Act, 1927 (Act No. 38 of 1927);
- 20 (d) a local authority as defined in the Black Local Authorities Act, 1982 (Act No. 102 of 1982);
- (e) a regional services council established under section 3 of the Regional Services Councils Act, 1985 (Act No. 109 of 1985); or
- 25 (f) a body or institution declared under subsection (2) a local government body for the purposes of this Act;".

Wet No. 84, 1988**WYSIGINGSWET OP PLAASLIKE OWERHEIDSOPLEIDING, 1988****Wysiging van artikel 2 van Wet 41 van 1985, soos gewysig deur artikel 30 van Wet 32 van 1987**

2. Artikel 2 van die Hoofwet word hierby gewysig—

- (a) deur die volgende paragraaf by subartikel (2) te voeg:
“(i) die provinsiale sekretaris van elke provinsie van die Republiek.”; en 5
(b) deur die volgende paragraaf by subartikel (3) te voeg:
“(f) die provinsiale sekretarisse, die betrokke provinsiale sekretaris.”.

Wysiging van artikel 8 van Wet 41 van 1985

3. Artikel 8 van die Hoofwet word hierby gewysig deur subartikel (3) deur die volgende subartikel te vervang:

“(3) Geld wat ingevolge subartikel (1) (a) en (b) toegeken word, mag slegs aangewend word om die uitgawe wat voortspruit uit die verskaffing van opleiding [ingevolge 'n goedgekeurde opleidingskursus voortspruit] wat deur die Opleidingsraad goedgekeur is, te bestry.”.

4. Hierdie Wet heet die Wysigingswet op Plaaslike Owerheidsopleiding, 1988.

LOCAL GOVERNMENT TRAINING AMENDMENT ACT, 1988

Act No. 84, 1988

Amendment of section 2 of Act 41 of 1985, as amended by section 30 of Act 32 of 1987

2. Section 2 of the principal Act is hereby amended—

(a) by the addition to subsection (2) of the following paragraph:

"(i) the provincial secretary of every province of the Republic."; and

5 (b) by the addition to subsection (3) of the following paragraph:

"(f) the provincial secretaries, the provincial secretary concerned.".

Amendment of section 8 of Act 41 of 1985

3. Section 8 of the principal Act is hereby amended by the substitution for subsection (3) of the following subsection:

10 "(3) Moneys allocated in terms of subsection (1) (a) and (b) may be utilized only to defray the expenditure arising from the provision of training [in terms of an] approved [training course] by the Training Board.".

Short title

4. This Act shall be called the Local Government Training Amendment Act, 1988.
