PUBLICATIONS OR OBJECTS.—PROHIBITION ON POSSESSION OF UNDESIRABLE PUBLICATIONS OR OBJECTS

PUBLIKASIES OF VOORWERPE.—VERBOD OP BESIT VAN ONGEWENSTE PUBLIKASIES OF VOOR- WERPE

A Committee referred to in section 4 of the Publications Act, 1974 (the Act), which decided under section 11 (2) of the Act that the undermentioned publications are undesirable within the meaning of section 47 (2) of the Act, has under section 9 (3) of the Act, prohibited the possession of the said publications. The said prohibition was confirmed by the Publications Appeal Board under section 9 (5) of the Act.
