Tot wysiging van die Grondwet van die Republiek van Suid-Afrika, 1983, ten einde ander voorsiening te maak met betrekking tot die tydperk waarbinne sekere advies en beslissings van die Presidentsraad in die Parlement ter Tafel gelê moet word.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 78 van Wet 110 van 1983

1. Artikel 78 van die Grondwet van die Republiek van Suid-Afrika, 1983, word hierby gewysig deur subartikel (8) deur die volgende subartikel te vervang:

“(8) Advies wat die Staatspresident ingevolge subartikel (4) (b) ontvang en deur hom aanvaar word, en 'n beslissing van die Presidentsraad ingevolge subartikel (5), moet so gou doenlik in elke Huis ter Tafel gelê word **[binne 14 dae na ontvangs daarvan deur die Staatspresident]**.”.

2. Hierdie Wet heet die Derde Wysigingswet op die Grondwet, 1988:

CONSTITUTION THIRD AMENDMENT ACT, 1988

Act No. 101, 1988

ACT

To amend the Republic of South Africa Constitution Act, 1983, so as to make different provision in relation to the period within which certain advice and decisions of the President's Council shall be laid upon the Table in Parliament.

(Assented to 12 October 1988.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 78 of Act 110 of 1983

1. Section 78 of the Republic of South Africa Constitution Act, 1983, is hereby
5 amended by the substitution for subsection (8) of the following subsection:
“(8) Advice received by the State President in terms of subsection (4) (b) and accepted by him, and any decision of the President's Council in terms of subsection (5), shall be laid upon the Table of every House **[within 14 days after its receipt by the State President]** as soon as possible.”.

10 Short title

2. This Act shall be called the Constitution Third Amendment Act, 1988.
