ORDER UNDER THE SECURITY EMERGENCY REGULATIONS, 1988

Under the powers vested in me by regulation 10 of the Security Emergency Regulations, 1988, I, Hendrik Gideon de Witt, Commissioner of the South African Police, hereby prohibit—

(a) the gathering organised or advertised by the "Delmas Trialists Ad-Hoc Support Committee" to be held in the "Flower Hall" at the University of the Witwatersrand on 6 December 1988; and

(b) any other gathering in the Republic, excluding in the self-governing areas, which has been or is being or may be organised—

(i) by the "Delmas Trialists Ad-Hoc Support Committee"; or

(ii) as a protest gathering against the so called "Delmas Trial".

In this notice a word to which a meaning has been assigned in the Security Emergency Regulations, 1988, shall have the same meaning.

BEVEL KRAGTENS DIE VEILIGHEIDSNOODREGULASIES, 1988

(b) enige ander byeenkoms in die Republiek, uitgesonder in die selfregerende gebiede, wat gereël of geadverteer is of word of mag word—

(i) deur die "Delmas Trialists Ad-Hoc Support Committee"; of

(ii) as 'n protesbyeenkoms teen die sogenoemde "Delmas-verhoor".

In hierdie kennisgewing het 'n woord waaraan 'n betekenis in die Veiligheidsnoodregulasies, 1988, geheg is, diezelfde betekenis.
