APPLICATION OF REGULATIONS	
<p>Definitions</p> <p>1. (1) In these regulations any word or expression to which a meaning has been assigned in the Act shall, unless the context otherwise indicates, have the meaning so assigned, and—</p> <p>“the Act” means the Electoral Act, 1979 (Act No. 45 of 1979);</p> <p>“Procedure Manual for Elections” means the Procedure Manual for Elections issued by the chief electoral officer.</p> <p>(2) Unless the context otherwise indicates, any reference in these regulations—</p> <ul style="list-style-type: none"> (a) to a section by a specific number shall be interpreted as a reference to the section of that number in the Act; and (b) to a form by a specific number shall be interpreted as a reference to the form of that number in Appendix A to these regulations. <p>Official languages</p> <p>2. Any form, notice or other document which in terms of the Act or these regulations is to be displayed for inspection by the public, at any place or in any manner whatsoever, shall be in the English as well as the Afrikaans language.</p> <p>NOMINATIONS</p> <p>Nomination of candidates</p> <p>3. (b) Any person who in terms of section 41 (3) wishes to propose a candidate in writing or to second such a proposal in writing shall do so by completing the applicable paragraph of Section A of form VE 2/1 and signing it after the particulars of the candidate concerned have been filled in in paragraph 1 of Section A of the said form.

(2) Any candidate who in terms of section 41 (4) (a) wishes to consent to his nomination in writing or wishes to confirm that he is legally competent in accordance with the meaning of that section or wishes to withdraw his consent to his nomination in terms of section 41 (6) may do so by completing the applicable section of Section A of form VE 2/1 and signing it.

(3) A statement referred to in section 41 (4) (b) (i) shall be made on Section B of form VE 2/1.

(4) Any candidate who is about to be nominated as an independent or as the representative of a political party which is not registered in terms of section 36 shall complete Section C of form VE 2/1 not later than four o' clock in the afternoon of the fifth day before nomination, sign it and hand it to the returning officer.

(5) The statements referred to in section 41 (4) (b) (ii) with regard to a specific candidate shall be made on Section D of form VE 2/1 and shall be handed to the returning officer together with Section C of form VE 2/1.

(6) If a candidate withdraws his consent to nomination in terms of section 41 (6), the sum deposited in terms of section 42 (1) shall be refunded to the depositor.

(7) Receipt of written nominations in terms of section 41 (3) that are handed to the returning officer after the publication of the notice referred to in section 34 (3), which have a bearing on the election in question, shall be acknowledged in writing by him.

(8) The returning officer shall as soon as possible after the close of the sitting of the nomination court report to the chief electoral officer by—

(a) in the event of only one person having been duly nominated and declared duly elected in terms of section 41 (8), furnishing particulars of such person telegraphically on form VE 2/4 and subsequently confirming the telegraphic report on form VE 2/3; or

(b) in the event of more than one person having been duly nominated, furnishing particulars of each of the persons telegraphically on form VE 2/6 and subsequently confirming the telegraphic report on form VE 2/7.

(9) If a candidate has in terms of section 41 (8) been declared duly elected the returning officer shall immediately after the close of the sitting of the nomination court display a notice on form VE 2/3 outside the entrance to the nomination court for at least 24 hours.

(2) 'n Kandidaat wat kragtens artikel 41 (4) (a) skriftelik tot sy nominasie wil toestem of wil bevestig dat hy ooreenkomsdig die bedoeling van daardie artikel wetlik bevoeg is of sy toestemming tot sy nominasie kragtens artikel 41 (6) wil terugtrek, kan dit doen deur die toepaslike gedeelte van Deel A van vorm VE 2/1 in te vul en te onderteken.

(3) 'n Verklaring bedoel in artikel 41 (4) (b) (i) moet gedoen word op Deel B van vorm VE 2/1.

(4) 'n Kandidaat wat genoem word as 'n onafhanklike of as die verteenwoordiger van 'n politieke party wat nie ingevolge artikel 36 geregistreer is nie, moet nie later nie as vieruur in die namiddag van die vyfde dag voor nominasiedag Deel C van vorm VE 2/1 invul en onderteken en by die kiesbeampte inlewer.

(5) Die verklarings bedoel in artikel 41 (4) (b) (ii) ten opsigte van 'n bepaalde kandidaat, moet gedoen word op Deel D van vorm VE 2/1 en moet saam met deel C van vorm VE 2/1 by die kiesbeampte ingelewer word.

(6) Indien 'n kandidaat sy toestemming tot nominasie kragtens artikel 41 (6) terugtrek, moet die deposito wat ingevolge artikel 42 (1) gestort is, aan die deponeerde terugbetaal word.

(7) Ontvangs van skriftelike nominasies kragtens artikel 41 (3) wat by die kiesbeampte ingelewer word na afkondiging van die kennisgewing in artikel 34 (3) bedoel, wat op die betrokke verkiesing betrekking het, moet skriftelik deur hom erken word.

(8) Die kiesbeampte moet so gou doenlik na afloop van die sitting van die nominasiehof aan die hoofverkiesingsbeampte verslag doen deur—

(a) indien slegs een persoon behoorlik genoem word en ooreenkomsdig artikel 41 (8) behoorlik verklaar is, besonderhede van sodanige persoon telegrafies op vorm VE 2/4 te verstrek en daarna die telegrafiese berig op vorm VE 2/3 te bevestig;

(b) indien meer as een persoon behoorlik genoem word, besonderhede van elk van die persone telegrafies op vorm VE 2/6 te verstrek en daarna die telegrafiese berig op vorm VE 2/7 te bevestig.

(9) Indien 'n kandidaat ooreenkomsdig artikel 41 (8) behoorlik verklaar is, moet die kiesbeampte onmiddellik na die einde van die sitting van die nominasiehof 'n kennisgewing op vorm VE 2/3 minstens 24 uur lank buite die ingang van die nominasiehof vertoon.

PRELIMINARY ARRANGEMENTS REGARDING ELECTION

Polling stations, polling day and polling hours.

4. (1) A notice referred to in section 43 (1) shall be issued on form VE 2/8.

(2) The prescribed manner as referred to in section 43 (1) (b) shall take place on form VE 2/9.

(3) The notice referred to in section 43 (2) shall take place on form VE 2/10.

Appointment of polling agents

5. An appointment of any person as a polling agent referred to in section 123 shall be done on form VE 5/4.

Appointment of presiding officers and polling officers

6. (1) The returning officer should appoint for each polling station a presiding officer and as many polling officers as appear to be necessary to facilitate the polling: Provided that where the number of voters registered in a polling district are not more than 200, the presiding officer should be assisted by only one polling officer.

(2) An appointment in terms of subregulation (1) shall be done on form VE 5/3.

(3) No person shall be appointed by the returning officer at a polling station as presiding officer or polling officer if he is in the service of any other person in connection with or for the purposes of the election.

Furniture for use at election

7. (1) The returning officer should ensure that every polling station is supplied with sufficient tables and chairs for use by polling officials and agents of candidates, and also with sufficient voting compartments.

(2) If the returning officer is convinced that the presiding officers at distant or other polling stations can hold the poll satisfactorily by arranging tables that are partitioned in such a manner that the voters can cast their votes in secret, it shall not be necessary to provide such polling stations with voting compartments.

Equipment, forms, stationery and other requirements for use at elections

8. (1) Instruments for the marking of ballot papers for voters voting by post and for the marking of ballot papers issued on polling day at polling stations shall differ completely in design.

(2) All equipment, forms, stationery and other requirements that are provided to a presiding officer for use in connection with an election shall be issued to him by the returning officer on form VE 5/2.

(3) Particulars of official marks and ballot papers for use on polling day may not be made known publicly before or on polling day.

(4) Any person who violates subregulation (3) shall be guilty of an offence and liable on conviction to a fine not exceeding R1 000.

VOTERS VOTING BY POST

Voting by voters who vote by post

9. (1) The returning officer shall note the accounts in section 107 (2) on form VE 4/16.

(2) The completed form VE 4/16 shall be forwarded to the chief electoral officer.

(3) The returning officer shall affix forms VE 5/15 and VE 5/17 (labels) to—

(a) the ballot box for voters voting by post, referred to in section 70; and

VOORAFGAANDE REELINGS IN VERBAND MET VERKIESING

Stemburo's, stemdag en stemure

4. (1) 'n Kennisgewing bedoel in artikel 43 (1) moet op vorm VE 2/8 uitgereik word.

(2) Die voorgeskrewe wyse soos in artikel 43 (1) (b) bedoel, geskied op vorm VE 2/9.

(3) Die kennisgewing in artikel 43 (2) bedoel, moet op vorm VE 2/10 geskied.

Benoeming van stemagents

5. 'n Benoeming van iemand as 'n stemagent bedoel in artikel 123 word gedoen op vorm VE 5/4.

Aanstelling van voorsittende beampies en stemopnemers

6. (1) Die kiesbeampte behoort vir elke stemburo 'n voorsittende beampte en soveel stemopnemers aan te stel as wat nodig blyk te wees om die stemming te ver gemaklik: Met dien verstande dat waar die getal kiesers vir 'n stendistrik ingeskryf hoogstens 200 is, die voorsittende beampte deur slegs een stemopnemer byge staan behoort te word.

(2) 'n Aanstelling ingevolge subregulasie (1) word gedoen op vorm VE 5/3.

(3) Niemand word deur die kiesbeampte by 'n stemburo as voorsittende beampte of stemopnemer aange stel nie indien hy in verband met, of vir doeleindes van die verkiesing, by iemand anders in diens is.

Meubels vir gebruik by verkiesing

7. (1) Die kiesbeampte behoort toe te sien dat elke stemburo van voldoende tafels en stoelle voorsien word vir gebruik deur stembeampies en agente van kandidate, asook van voldoende stemkompartemente.

(2) Indien die kiesbeampte oortuig is dat die voorsittende beampte by afgeleë of ander stemburo's die stemming bevredigend kan hou deur tafels in te rig wat op so 'n wyse afgeskort word dat die kiesers in die geheim hul stemme kan uitbring, is dit nie nodig om sodanige stemburo's van stemkompartemente te voor sien nie.

Toerusting, vorms, skryfbehoeftes en ander benodigd hede vir gebruik by verkiesings

8. (1) Werktuie vir die merk van stembriewe vir kiesers wat per pos stem en vir die merk van stembriewe wat op stemdag in stemburo's uitgereik word, moet geheel en al in ontwerp verskil.

(2) Alle toerusting, vorms, skryfbehoeftes en ander benodigd hede wat aan 'n voorsittende beampte verskaf word vir gebruik in verband met 'n verkiesing, word op vorm VE 5/2 deur die kiesbeampte aan hom uitgereik.

(3) Besonderhede van amptelike merke en stembriewe vir gebruik by die stemming mag nie voor of op stemdag bekendgemaak word nie.

(4) Iemand wat subregulasie (3) oortree, is aan 'n misdryf skuldig en is by skuldig bevinding strafbaar met 'n boete van hoogstens R1 000.

KIESERS WAT PER POS STEM

Stemming deur kiesers wat per pos stem

9. (1) Die kiesbeampte moet die verslae in artikel 107 (2) op vorm VE 4/16 aanteken.

(2) Die ingevulde vorm VE 4/16 moet aan die hoofverkiesingsbeampte gestuur word.

(3) Die kiesbeampte moet vorms VE 5/15 en VE 5/17 (etikette) plak op onderskeidelik—

(a) die stembus vir kiesers wat per pos stem, bedoel in artikel 70; en

(b) the receptacle for ballot paper envelopes of voters voting by post, referred to in section 76 (1), respectively.

(4) The form of declaration of identity referred to in section 58 (1) shall be form VE 4/6.

(5) The electoral officer shall compare the signatures on copies of applications for postal votes submitted to him by the returning officer in terms of the proviso to section 52 (1) (c) with the official records at his disposal: Provided that should he, with such comparison find that one or both of the aforementioned signatures is or are not the signature(s) of the person in question who has applied for a postal vote, he shall submit the copies of the applications concerned together with his report to the S.A. Police for further investigation and action.

SPECIAL VOTERS

Supplies

10. Before the date ten days after nomination day the electoral officer shall furnish every presiding officer for votes of special voters with—

- (a) a copy of the Procedure Manual for Elections;
- (b) a supply of the envelopes, forms and labels VE 3/3, VE 3/4, VE 3/5, VE 3/6, VE 3/7, VE 3/9, VE 3/10, VE 3/16, VE 3/17 and VE 5/21; and
- (c) a supply of official envelopes E10, sealing-wax, ballot pencils, paper and pens.

Allocation of serial numbers to applications

11. The serial number—

- (a) referred to in section 82 (2) (b) which is to be noted by the presiding officer for votes of special voters on the application form (VE 3/3) and on the reverse side of the special covering envelope (VE 3/9) referred to in section 87 (4) shall be obtained with the entry of each application on the list (VE 3/5) referred to in section 89 (3); and
- (b) referred to in section 91 (3) (b) which is to be recorded by the returning officer on the application form (VE 3/3) and on the ballot paper envelope (VE 3/7), shall be obtained with the entry of every application on the list (VE 3/14) referred to in section 91 (3) (c).

Rejection of applications

12. If the presiding officer for votes of special voters rejects an application of any person to vote as a special voter (VE 3/3) he shall—

- (a) without delay notify the applicant of the rejection and the reason therefor on form VE 3/10, which is to be handed to the applicant personally;
- (b) mark both copies of the application in question "rejected", endorse the reason for the rejection theron; and
- (c) file such applications with the copies of accepted applications in numerical sequence according to the serial numbers allocated thereto in terms of regulation 11 (a).

Keeping of receipts issued

13. (1) A presiding officer for votes of special voters shall with regard to every covering envelope received make out a receipt on form VE 3/16.

(2) After the close of the poll the preceding officer referred to in subregulation (1) shall provide the returning officer with the receipts referred to.

(b) die houer vir stembriefkoeverte van kiesers wat per pos stem bedoel in artikel 76 (1).

(4) Die vorm van identiteitsverklaring bedoel in artikel 58 (1) is vorm VE 4/6.

(5) Die verkiesingsbeampte moet die handtekening op afdrukke van aansoek om posstemme wat deur die kiesbeampte ingevolge die voorbehoudsbepaling by artikel 52 (1) (c) aan hom voorgelê is, met die amptelike rekords tot sy beskikking vergelyk: Met dien verstande dat indien hy met sodanige vergelyking vind dat een van of albei die voormalde handtekeninge nie die handtekening(e) is nie van die betrokke persoon wat om 'n posstem aansoek gedoen het, lê hy die afdrukke van die betrokke aansoek tesame met sy verslag aan die S. A. Polisie vir verdere ondersoek en optrede voor.

SPESIALE KIESERS

Voorrade

10. Voor die datum tien dae na nominasiedag voor-sien die verkiesingsbeampte elke voorsittende beampte vir stemme van spesiale kiesers van—

- (a) 'n eksemplaar van die Procedurehandleiding vir Verkiegings;
- (b) 'n voorraad van die koeverte, vorms en etikette VE 3/3, VE 3/4, VE 3/5, VE 3/6, VE 3/7, VE 3/9, VE 3/10, VE 3/16, VE 3/17 en VE 5/21; en
- (c) 'n voorraad amptelike koeverte E10, lak, stem-potlode, papier en penne.

Toekenning van volgnommers aan aansoek

11. Die volgnommer—

- (a) bedoel in artikel 82 (2) (b) wat deur die voorsittende beampte vir stemme van spesiale kiesers op die aansoekvorm (VE 3/3) aangeteken moet word asook op die agterkant van die spesiale omslagkoevert (VE 3/9) bedoel in artikel 87 (4), word verkry met die inskrywe van elke aansoek op die lys (VE 3/5) bedoel in artikel 89 (3); en
- (b) bedoel in artikel 91 (3) (b) wat deur die kiesbeampte op die aansoekvorm (VE 3/3) aangeteken moet word asook op die stembriefkoevert (VE 3/7), word verkry met die inskrywe van elke aansoek op die lys (VE 3/14) bedoel in artikel 91 (3) (c).

Afwysing van aansoek

12. Indien die voorsittende beampte vir stemme van spesiale kiesers 'n aansoek van iemand om as spesiale kieser te stem (VE 3/3) afwys, moet hy—

- (a) die aansoeker onverwyd op vorm VE 3/10, wat aan die aansoeker persoonlik oorhandig moet word, van die afwysing en die rede daarvoor in kennis stel;
- (b) albei afskrifte van die betrokke aansoek merk "verwerp", die rede vir die verwerpding daarop endosseer; en
- (c) sodanige aansoek liasseer by die afskrifte van aanvaarde aansoek in numeriese volgorde ooreenkomsdig die volgnommers ingevolge regulasie 11 (a) daaraan toegeken.

Bewaring van uitgereikte kwitansies

13. (1) 'n Voorsittende beampte vir stemme van spesiale kiesers moet ten opsigte van elke onvange omslagkoevert 'n kwitansie op vorm VE 3/16 uitmaak.

(2) Na afloop van die verkiesing moet die voorsittende beampte in subregulasie (1) genoem die bedoelde kwitansies aan die kiesbeampte besorg.

Voting by special voters

14. (1) The returning officer shall complete a ballot paper account referred to in section 107 (2) for special voters on form VE 4/16.

(2) A copy shall be forwarded to the chief electoral officer, by making use of form VE 4/16.

(3) The returning officer shall affix a form VE 5/16 (label) to the ballot box for special voters, referred to in section 90.

VOTING AT POLLING STATIONS**Preparatory work before the commencement of the poll**

15. (1) The presiding officer and polling officers shall report at the polling station at least 30 minutes before the time that has been determined for the commencement of the poll and do all preparatory work so that the poll may commence exactly at the time referred to in section 94.

(2) Every voting compartment shall be placed and arranged in such a manner that any person who enters or leaves it can be seen by the presiding officer or his assistants.

(3) A ballot box at a polling station shall, after the candidates or any agents of the candidates who may be present have satisfied themselves that it is empty, be sealed by the presiding officer in the presence of the candidates or agents present.

(4) The presiding officer shall affix the following notices and labels:

- (a) Form VE 5/7 (notice) at the main entrance of the polling station;
- (b) form VE 5/18 (label) to the ballot box referred to in section 96 (5);
- (c) form VE 5/19 (label) to the ballot box referred to in section 98 (f).

Seclusion of voter in voting compartment

16. The presiding officer shall not allow any person other than a voter who wishes to vote, to enter a voting compartment during the ballot or to come close to it and he shall not allow any person to talk to a voter who is marking his ballot paper, except in the case of a blind person or any other voter who is physically incapacitated as provided for in section 100.

Tendered ballot papers

17. A ballot paper issued to any person in terms of section 101 shall, after he has marked it, be placed in an envelope VE 5/13 by the presiding officer and sealed.

Objections against identification in terms of section 97 (1)

18. (1) The affidavit in which proof of identity is produced in terms of section 97 (1), shall take place on form VE 5/6.

(2) If an objection in terms of the proviso to section 97 (1) has been noted on such an affidavit, that affidavit shall after close of the poll be sealed by the presiding officer in a separate envelope for handing to the returning officer.

Supervision by returning officer

19. The returning officer shall exercise supervision over the ballot and the presiding officers or other persons who are concerned in the election or who have an interest therein shall, as far as possible, be able to reach him by telephone or otherwise, and in municipal areas he shall, as far as practicable, inspect every polling station in his division on polling day.

19. COUNTING OF BALLOT PAPERS AND RESULT OF POLL

Where ballot boxes are to be taken in receipt and votes are to be counted

20. (1) The returning officer shall appoint the time and place where he is going to take the ballot boxes in receipt and count the votes, and shall notify the presiding officers and election agents accordingly.

(2) The place thus determined may be within or outside the division, according to whether it appears to the returning officer to be the most convenient place for the purpose.

Counting officers and counting hall

21. (1) The returning officer shall appoint as many counting officers as are necessary to assist him to determine the result of the poll as rapidly as possible.

(2) Counting officers shall as far as possible be appointed from the presiding officers and polling officers.

(3) During the counting of votes no person shall be allowed by the returning officer to enter the counting hall, except the presiding officers or polling officers or other officials who deliver the ballot boxes and other packets, the counting officers, the candidates and their spouses and the agents of such candidates, and it must be ensured that all these persons have taken the declaration of secrecy on form VE 5/5.

Counting of votes

22. (1) The returning officer may listen to any objection or argument against or in favour of the acceptance or rejection of a ballot paper which is advanced by a candidate or an agent of such candidate.

(2) The returning officer shall note the word "rejected" on each ballot paper he rejects as invalid, and if there is an objection to his decision he shall note the word "objection raised against rejection" thereon, and where in similar manner objection has been made to the acceptance of a ballot paper he shall note the words "objection raised against acceptance" thereon.

(3) No person who is present at the counting of the votes of voters voting by post and special voters or other votes shall, before the final result of the poll has been made known publicly by the returning officer, divulge any information concerning the result of the poll or the number of votes cast in favour of a particular candidate to any person outside the counting hall.

(4) Any person who violates subregulation (3) shall be guilty of an offence and liable on conviction to a fine not exceeding R1 000.

Declaration of result of poll

23. (1) Immediately after the result of the poll has been determined in terms of section 104 it shall be filled in on form VE 6/1 and read out inside and outside the counting hall.

(2) When the returning officer forwards the account on form VE 6/3 referred to in section 108 (2) to the chief electoral officer he shall attach thereto an analysis of the result of the poll on form VE 6/3 (1).

Labels for packets in which electoral matter is made up

24. The returning officer shall affix a label on form VE 5/21 to every packet which is made up in terms of section 107 (1).

SUNDRY PROVISIONS**Prescribed fees for certain documents**

- (b) in section 107 (6) shall amount to 50c per page or part thereof with a minimum, in the case of a voters' list, of R10 per voters' list or part thereof.

Dealing with objections in terms of section 97 (1)—

26. (1) the returning officer shall dispatch the envelope containing objections referred to in regulation 18 to the electoral officer as soon as practicable after the day following the day on which the counting is completed.
- (2) the electoral officer shall compare all the particulars and the signature of the person who has in terms of section 97 (1) been identified as the voter concerned whose name appears on the voters' list, with the official records at his disposal. If he finds with such comparison that the particulars or signature of the identified person do not according to the official records correspond with those of the registered voter, he shall submit copies of the affidavits concerned together with his report to the S.A. Police for further action.

Repeal of regulations

27. The election regulations promulgated by Government Notice No. R. 1999 of 6 September 1985 are hereby repealed.

INFRINGEMENT OF SECRECY**Section 117 of the Electoral Act, 1979**

117.—(1) Every officer, candidate and agent in attendance at a polling station shall maintain, and aid in maintaining the secrecy of the voting in that station, and shall not, before the poll is closed, communicate, except for some purpose authorised by law to any person any information likely to defeat the secrecy of the voting.

(2) No person, expect as in this Act provided, shall interfere with or attempt to interfere with a voter when marking his vote, or otherwise attempt to obtain in the polling station information as to the candidate for whom any voter in that station is about to vote or has voted, or communication at any time to any person any information obtained in a polling station as to the candidate for whom any voter in such station is about to vote or has voted or as to the number on the back of the ballot papers given to any voter at such station.

(3) No persons shall directly or indirectly induce any voter to display, his ballot paper, after he has marked it, in such manner as to make known to any person the name of the candidate for whom the voter has so marked his vote.

(4) No person shall place upon any ballot paper any mark or writing whereby a person who gives his vote on that ballot paper may be identified.

(5) Every person in attendance at the counting of the votes shall maintain and aid in maintaining, the secrecy of the voting, and shall not attempt to ascertain at such counting the number on the back of any ballot paper or communicate any information obtained at such counting as to the candidate for whom any vote is given in any particular ballot paper.

(6) Subject to the provisions of section 100, no person shall attempt to ascertain, or directly or indirectly aid in ascertaining for which candidate any voter has given his vote.

(7) A person who has, in the carrying out of his duties under this Act, obtained knowledge as to the candidate for whom any other person has voted shall not, except in answer to a question lawfully put to him in the course of proceedings in a competent court, disclose such knowledge.

(8) No person shall, expect upon the order of a competent court or as authorised by this Act, break the seal of or open any such sealed packet as is mentioned in section 103 or 107.

(9) Any person who contravenes or fails to comply with any provision of this section shall be guilty of an offence and liable on conviction to a fine not exceeding R2 000 or to imprisonment for a period not exceeding 12 months.
