## GOVERNMENT NOTICE

### SOUTH AFRICAN POLICE

No. 1917

25 August 1989

### ORDER UNDER THE SECURITY EMERGENCY REGULATIONS, 1989

Under the powers vested in me by regulation 10 of the Security Emergency Regulations, 1989, I, Hendrik Gideon de Witt, Commissioner of the South African Police, hereby prohibit the holding of the gathering specified in Schedule A otherwise than in accordance with the conditions specified in Schedule B.

#### SCHEDULE A

The gathering organized and advertised by the CONGRESS OF SOUTH AFRICAN TRADE UNIONS and the NATIONAL COUNCIL OF TRADE UNIONS to be held at the Shareworld Complex, Johannesburg, under the banner of a "Workers Summit" on 26 and 27 August 1989.

#### SCHEDULE B

#### Definitions

1. In this Schedule, unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the Security Emergency Regulations, 1989, has a corresponding meaning, and—

"trade union" means a trade union as described in the Labour Relations Act, 1956 (Act No. 28 of 1956), as amended.

#### Conditions

2. (1) No person who is not a member of a trade union shall attend or stay present at the gathering specified in Schedule A.

(2) No person acting as a speaker at the gathering specified in Schedule A, shall deal with a subject not dealt with under the Labour Relations Act, 1956 (Act No. 28 of 1956), as amended or section 25 of the Railways and Harbours Service Act, 1925 (Act No. 23 of 1925), as amended.

### BEVEL KAGTENS DIE VEILIGHEIDS-NOODREGULASIES, 1989

#### BYLAE A

Die byeenkoms wat deur die CONGRESS OF SOUTH AFRICAN TRADE UNIONS en die NATIONAL COUNCIL OF TRADE UNIONS gereel en geadverteer is om gehou te word by die "Shareworld" kompleks, Johannesburg, onder die vaandel van 'n "Workers Summit" op 26 en 27 Augustus 1989.

#### BYLAE B

#### Woordomskrywing

1. In hierdie Bylae, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan in die Veiligheidsnoodregulasies, 1989, 'n betekenis geheg is 'n ooreenstemmende betekenis, en beteken—

"vakvereniging" 'n Vakvereniging soos omskryf in die Wet op Arbeidsverhoudinge, 1956 (Wet No. 28 van 1956), soos gewysig.

2. (1) Geen persoon wat nie 'n lid van 'n vakvereniging is, mag die byeenkoms in Bylae A omskryf bywoon of daar aanwesig bly nie.

(2) Geen persoon wat as 'n spreker by die byeenkoms omskryf in Bylae A optree, mag met onderwerpe handel wat nie onder die Wet op Arbeidsverhoudinge, 1956 (Wet No. 28 van 1956), soos gewysig, of artikel 25 van die Spoorwegen en Havens Dienst Wet, 1925 (Wet No. 23 van 1925), soos gewysig, behandel word nie.

(3) The proceedings in connection with the gathering specified in Schedule A shall take place between the hours of 09:00 and 17:00 on any day.

(4) No person shall display or distribute any flags, banners, placards, pamphlets, stickers or posters at the gathering specified in Schedule A except insofar as such flag, banner, placard, pamphlet, sticker or poster stands in connection with a subject dealt with under the Labour Relations Act, 1956 (Act No. 28 of 1956), or section 25 of the Railways and Harbours Service Act, 1925 (Act No. 23 of 1925), as amended.

(5) No person shall attend or stay present at the gathering specified in Schedule A where a condition imposed under this order is not complied with.

#### **Application of this order**

3. This order shall apply in the Magisterial Districts of Germiston, Kempton Park, Krugersdorp, Johannesburg, Randburg, Roodepoort, Springs and Vereeniging.

(3) Die verrigtinge in verband met die byeenkoms in Bylae A omskryf mag net geskied tussen die ure van 09:00 en 17:00 op enige dag.

(4) Geen persoon mag enige vlae, baniere, plakkate, pamphlette, plakkertjies of aanplakbiljette by die byeenkoms in Bylae A omskryf vertoon of versprei nie, behalwe insoverre sodanige plakkate, pamphlette, plakkertjies of aanplakbiljette in verband staan met onderwerpe wat onder die Wet op Arbeidsverhoudinge, 1956 (Wet No. 28 van 1956), soos gewysig, of artikel 25 van die Spoerwegen en Havens Dienst Wet, 1925 (Wet No. 23 van 1925), soos gewysig, behandel word.

(5) Geen persoon mag die byeenkoms in Bylae A omskryf bywoon of daar aanwesig bly indien daar nie aan 'n voorwaarde kragtens hierdie bevel opgelê, voldoen word nie.

#### **Toepassing van hierdie bevel**

3. Hierdie bevel is van toepassing in die landdrosdistrikte van Germiston, Kempton Park, Krugersdorp, Johannesburg, Randburg, Roodepoort, Springs en Vereeniging.
