#### VERKLARING VAN 'N TOLPAD. — PROVINSIE NATAL

Die Suid-Afrikaanse Padraad ingestel ingevolge die bepalings van artikel 2 van die Wet op die Suid-Afrikaanse Padraad, 1988 (Wet No. 74 van 1988), verklaar hierby, ingevolge die bepalings van artikel 9 (1) (a) van die Wet op Nasionale Paaie, 1971 (Wet No. 54 van 1971), dat daardie gedeelte van Nasionale Pad N2, Seksie 22, soos verklaar by Proklamasies Nos. 181 van 1985, 84 van 1975, 165 van 1976 en 283 van 1978, tussen Imbezana en die Mzumberivier en daardie gedeelte van Nasionale Pad N2, Seksie 23, soos verklaar by Proklamasie No. 7 van 1981, tussen die Mzumberivier en die noordelike eindpunte van die op- en afritte noord van die Hibberdenewisselaar wat geleë is in die onmiddellike nabyheid van Padreserwebakens L32 en R33 van laasgenoemde Proklamasie, 'n tolpad is.

#### DECLARATION OF A TOLL ROAD. — PROVINCE OF NATAL

The South African Roads Board established in terms of section 2 of the South African Roads Board Act, 1988 (Act No. 74 of 1988), hereby, in terms of section 9 (1) (a) of the National Roads Act, 1971 (Act No. 54 of 1971), declares that that section of National Road N2, Section 22, as declared by Proclamations Nos. 181 of 1985, 84 of 1975, 165 of 1976 and 283 of 1978, between Imbezana and the Mzumber River and that portion of National Road N2, Section 23, as declared by Proclamation No. 7 of 1981, between the Mzumber River and the northern extremities of the on and off ramps north of Hibberdene Interchange which are situated in the immediate vicinity of Road Reserve Beacons L32 and R33 of the last-mentioned Proclamation, shall be a toll road.
