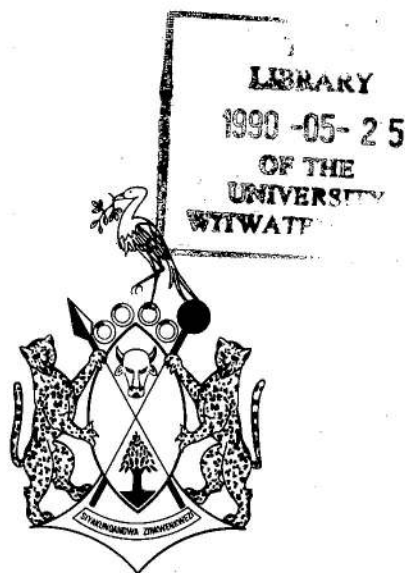

POLICE AMENDMENT DECREE, 1990

DEPARTMENT OF JUSTICE, POLICE AND PRISONS

POLICE AMENDMENT DECREE, 1990

DECREE No. 13 OF 1990

To amend the Police Act, 1983 and to provide for incidental matters.

BE IT DECREED by the Council of State of the Republic of Ciskei as follows:-

1. Amendment of section 1 of Act 32 of 1983, as amended by section 1 of Act 21 of 1985. - (1) The Police Act, 1983 (hereinafter referred to as the principal Act) is hereby amended —

(a) by the insertion after the definition of "Government" of the following definition:

" 'Head of State' means the Chairman of the Council of State of the Republic of Ciskei;";

(b) by the substitution for the definition of "Minister" of the following definition:

" 'Minister' means the person appointed by the Head of State in terms of section 5 of the Executive Government Decree, 1990 (Decree No. 2 of 1990) to administer the Department of Law and Order;".

(2) Nothing in subsection (1) or in the principal Act or in any other law contained shall be construed as prohibiting or preventing any executive or other committee of the Council of State from administering the Department of Law and Order, pending the appointment by the Chairman of that Council of a person to administer the said department.

2. Substitution of word "President" in Act 32 of 1983. - The principal Act is hereby amended by the substitution for the word "President", wherever it occurs, of the words "Head of State".

3. Amendment of laws. - (1) The laws mentioned in the Schedule are hereby amended in the manner set forth therein.

(2) Subject to the foregoing provisions of this Decree, there are hereby substituted in any law for the words "Minister of Justice, Police and Prisons" the words "Minister of Justice and Prisons".

4. Short title. - This Decree shall be called the Police Amendment Decree, 1990.

SCHEDULE

(1) The Public Service Act, 1981 (Act 2 of 1981) amended in Schedule 1 thereof —

(a) by the substitution for the words "Department of Justice, Police and Prisons" and "Director-General, Department of Justice, Police and Prisons" of the words "Department of Justice and Prisons" and "Director-General, Department of Justice and Prisons", respectively; and

(b) by the insertion in Columns 1 and 2 of the said Schedule, immediately below the words mentioned in paragraph (a), of the words "Department of Law and Order" and "Commissioner of the Ciskeian Police", respectively.

(2) The National Security Act, 1982 (Act 13 of 1982) amended by the substitution in section 1 for the definition of "Minister" of the following definition:

" 'Minister' means, subject to the provisions of section 1(2) of the Police Amendment Decree, 1990, the Councillor of State for the Department of Law and Order;".

(3) The Arms and Ammunition Act, 1984 (Act 41 of 1984) amended by the substitution in subsection (1) of section (1) for the definition of "Minister" of the following definition:

" 'Minister' means, subject to the provisions of section 1(2) of the Police Amendment Decree, 1990, the Councillor of State for the Department of Law and Order;".
