LIQUOR ACT AMENDMENT DECREE, 1990

DECREE No. 27 OF 1990

To amend the Liquor Act, 1983 by the prohibition of sorghum beer.

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

1. (1) Amendment of Section 1 of Act 13 of 1983. - Section 1 of the Liquor Act 1983 is hereby amended:

- (a) by the deletion of the definition of "beer drink";
- (b) by the deletion of paragraph (c) under the definition "liquor";
- (c) by the deletion of the words "a sorghum beer brewer's licence" and "a sorghum beer licence or" under the definition "off-consumption licence";
- (d) by the deletion of the words "a sorghum beer licence" under the definition "on-consumption licence";
- (e) by the substitution for the definition of "sorghum beer" of the following -
 - (a) the drink generally known as sorghum beer and commonly manufactured from grain sorghum, millet or other grain; or
 - (b) any other fermented liquor which the Councillor may from time to time by notice in the Government Gazette declare to be sorghum beer;"

2. Amendment of Section 10 of Act 13 of 1983. - Section 10 of the Liquor Act 1983 is hereby amended by the deletion of the words "and sorghum beer" in paragraphs (a)(ii), (iii), (iv), (v), and (c) of subsection (4).

3. Amendment of Section 42 of Act 13 of 1983. - Section 42 of the Liquor Act 1983 is hereby amended by the deletion of paragraphs (e) and (f), and the substitution thereof of the following:

"(e) if such licence is a mealtime wine and malt liquor licence for which application has been made by the keeper of an accommodation establishment, that the premises shall at all times afford reasonable residential accommodation for guests."

4. Amendment of Section 60 of Act 13 of 1983. - Section 60 of the Liquor Act 1983 is hereby amended by the deletion of the words "a sorghum beer brewer's licence or" in paragraph (d) of subsection (1).

5. Amendment of Section 64 of Act 13 of 1983. - Section 64 of the Liquor Act 1983 is hereby amended by the deletion of subsection (4).

6. Amendment of Section 66 of Act 13 of 1983. - Section 66 of the Liquor Act 1983 is hereby amended by the deletion of the words "(other than the holder of a sorghum beer brewer's licence)" in paragraph (b).

7. Amendment of Section 136 of Act 13 of 1983. - Section 136 of the Liquor Act 1983 is hereby amended by the deletion of subsection (6).

8. Amendment of Schedule 1 of Act 13 of 1983. - Schedule 1 of the Liquor Act 1983 is hereby amended:-

- (a) by the deletion of the words "or a licence authorising the sale of sorghum beer" in Item 6 of Part 1;
- (b) by the deletion of Item 7 and Item 10 of Part 1;
- (c) by the deletion of the terms "sorghum beer licence" and "sorghum beer brewer's licence" and the corresponding fees therefor in Parts 2 and 3.

9. Repeal of certain Sections of Act 13 of 1983. - Sections 124, 125, 126 and 127 of the Liquor Act 1983 are hereby repealed.

10. Amendment of Section 82 of Act 13 of 1983. - Section 82 of the Liquor Act 1983 is hereby amended by the deletion of paragraph (d) and the substitution thereof of the following:

- "(d) any drink produced by the distillation of any concoction referred to in paragraph (a), (b) or (c); or
- (e) sorghum beer."

11. Interpretation of existing licenses. - Notwithstanding the wording of any existing licence, no such licence shall, after the date of publication of this Decree in the Government Gazette, be interpreted in such a manner as to render lawful the brewing, selling, dealing in or disposal of sorghum beer.

12. Short title. - This Decree shall be called the Liquor Act Amendment Decree, 1990.
