NOTICE OF THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA

NOTICE OF INDEMNITY IN TERMS OF THE INDEMNITY ACT, 1990 (ACT No. 35 OF 1990)

By virtue of the powers vested in me by section 2 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), I hereby grant unconditional indemnity to Mncedisi Jason Sishuba, born 14 March 1948, in respect of the events specified hereunder:

(a) Theft of a typewriter and a duplicating machine from a school in Soweto.

(b) Escaping from lawful custody on 15 November 1977.

(c) Departing from the Republic of South Africa with the purpose of going to another country, during or about December 1977, without being in possession of a valid passport or permit as contemplated in section 2 (a) of the Departure from the Union Regulation Act, 1955 (Act No. 34 of 1955).

(d) Departing from the Republic of South Africa with the purpose of going to another country, during or about December 1977, at a place other than a port referred to in section 2 (b) of the Departure from the Union Regulation Act, 1955 (Act No. 34 of 1955).

KENNISGEWING VAN VRYWARING KRAGTENS DIE WET OP VRYWARING, 1990 (WET No. 35 VAN 1990)

(c) Vertrek uit die Republiek van Suid-Afrika met die doel om na 'n ander land te gaan gedurende of rondom Desember 1977, sonder om by sodanige verlatting in besit te wees van 'n geldige paspoort of permit soos bedoel in artikel 2 (a) van die Wet tot Reëling van Vertrek uit die Unie, 1955 (Wet No. 34 van 1955).

(d) Vertrek uit die Republiek van Suid-Afrika met die doel om na 'n ander land te gaan gedurende of rondom Desember 1977, by 'n plek ander dan 'n toegangspoort soos bedoel in artikel 2 (b) van die Wet tot Reëling van Vertrek uit die Unie, 1955 (Wet No. 34 van 1955).
