ESKOM AMENDMENT ACT, 1991

ACT

To amend the Eskom Act, 1987, so as to amend the definition of "Minister"; and to further regulate the constitution of the Electricity Council; and to provide for matters connected therewith.

(*English text signed by the State President.*)
(Assented to 18 March 1991.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 40 of 1987

1. Section 1 of the Eskom Act, 1987, is hereby amended by the substitution for the definition of "Minister" of the following definition:
"Minister" means the Minister of **[Economic]** Mineral and Energy Affairs and Technology] Public Enterprises;";

Amendment of section 5 of Act 40 of 1987

2. Section 5 of the Eskom Act, 1987, is hereby amended—
(a) by the substitution for paragraph (c) of subsection (1) of the following 10 paragraph:
"(c) the Director-General: Finance or an alternate member designated by the Minister of Finance;";
(b) by the substitution for paragraph (d) of subsection (1) of the following paragraph:
"(d) an officer who is in the employment of the Department of **[Economic Affairs and Technology]** Mineral and Energy Affairs and who shall be designated by the Minister;";
(c) by the substitution in paragraph (f) of subsection (1) for the words preceding subparagraph (i) of the following words:
"**[eight]** seven members appointed by the Minister, of whom—";
(d) by the substitution for subparagraph (ii) of paragraph (f) of subsection (1) of the following subparagraph:
"(ii) one shall be so appointed from among four persons whose names have been submitted for that purpose by the **[Association of Chambers of Commerce of South Africa]** South African Chamber of Business; and
(e) by the deletion of subparagraph (iii) of paragraph (f) of subsection (1).

Tot wysiging van die Eskomwet, 1987, ten einde die omskrywing van "Minister" te wysig; en die samestelling van die Elektrisiteitsraad verder te reël; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:

Wysiging van artikel 1 van Wet 40 van 1987

1. Artikel 1 van die Eskomwet, 1987, word hierby gewysig deur die omskrywing van "Minister" deur die volgende omskrywing te vervang:
"Minister" die Minister van **[Ekonomiese Sake en Tegnologie]** **Mineraal- en Energiesake en Openbare Ondernemings";**

Wysiging van artikel 5 van Wet 40 van 1987

2. Artikel 5 van die Eskomwet, 1987, word hierby gewysig—
- 10 (a) deur paragraaf (c) van subartikel (1) deur die volgende paragraaf te vervang:
"(c) die Direkteur-generaal: Finansies of 'n plaasvervangende lid deur die Minister van Finansies aangewys;";
- 15 (b) deur paragraaf (d) van subartikel (1) deur die volgende paragraaf te vervang:
"(d) 'n beampte wat in die diens van die Departement van **[Ekonomiese Sake en Tegnologie]** **Mineraal- en Energiesake** is en deur die Minister aangewys word;";
- 20 (c) deur in paragraaf (f) van subartikel (1) die woorde wat subparagraaf (i) voorafgaan deur die volgende woorde te vervang:
"**[agt]** **sewe** lede deur die Minister aangestel, van wie—";
- (d) deur subparagraaf (ii) van paragraaf (f) van subartikel (1) deur die volgende subparagraaf te vervang:
"(ii) een aldus aangestel word uit vier persone wie se name vir dié doel voorgelê is deur die **[“Association of Chambers of Commerce of South Africa”]** Suid-Afrikaanse Besigheidskamer;"; en
- 25 (e) deur subparagraaf (iii) van paragraaf (f) van subartikel (1) te skrap.
