ROODEPOORT AND WELTEVREDEN AGRICULTURAL SETTLEMENTS ADJUSTMENT AMENDMENT ACT, 1991

GENERAL EXPLANATORY NOTE:

ACT

To amend the Roodepoort and Weltevreden Agricultural Settlements Adjustment Act, 1966, so as to further regulate the abolition of the committees of management; and to regulate the ownership of those portions of the common grazing ground of the Weltevreden Agricultural Settlement which were not divided into lots; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows: —

Amendment of section 3 of Act 53 of 1966

1. Section 3 of the Roodepoort and Weltevreden Agricultural Settlements Adjustment Act, 1966 (hereinafter referred to as the principal Act), is hereby amended—

(a) by the substitution for paragraph (a) of subsection (1) of the following paragraph:

“(a) Iprovision for the management of] irrigation boards have been established in terms of section 79 of the Water Act, 1956 (Act No. 54 of 1956), for the areas referred to in the definition of “Settlement” in section 1 of the [said Ordinance has been made in terms of the Small-Holdings Ordinance, 1954 (Ordinance No. 17 of 1954) of the Orange Free State] Agricultural Settlements Private Ordinance, 1907, of the Orange Free State; and”; and

(b) by the substitution for subsection (2) of the following subsection:

“(2) Subject to the provisions of section 2, as from the date specified in any proclamation issued under subsection (1) of this section, all the assets and rights of the Committees of Management shall vest in, and all their liabilities and obligations shall devolve upon, [any peri-urban authority exercising control in terms of the said Small-Holdings Ordinance, 1954, over the areas] the irrigation board concerned which has been established for an area mentioned in subsection (1) (a) of this section.”

Amendment of section 3A of Act 53 of 1966, as inserted by section 1 of Act 38 of 1990

2. Section 3A of the principal Act is hereby amended by the substitution for subsection (1) of the following subsection:

“(1) The ownership of those portions of the common grazing ground of the Roodepoort and Weltevreden Agricultural [Settlement] Settlements which have not been divided into lots, shall vest in the State.”

Tot wysiging van die Reëlingswet op die Landbounedersettings Roodepoort en Weltevreden, 1966, ten einde die afskaffing van die bestuurskomitees verder te reël; en die eiendomsreg oor daardie gedeeltes van die gemeenskaplike weiveld van die Landbounedersetting Weltevreden wat nie in persele verdeel is nie, te reël; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

Wysiging van artikel 3 van Wet 53 van 1966

1. Artikel 3 van die Reëlingswet op die Landbounedersettings Roodepoort en Weltevreden, 1966 (hieronder die Hoofwet genoem), word hierby gewysig—
- 5 (a) deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:
 “(a) [daar ingevolge die Ordonnansie op Kleinhoeves, 1954 (Ordonnansie No. 17 van 1954), van die Oranje-Vrystaat, vir die bestuur van] besproeiingsrade ingevolge artikel 79 van die Waterwet, 1956 (Wet No. 54 van 1956), vir die gebiede genoem in die omskrywing van “Settlement” in artikel 1 van die Agricultural Settlements Private Ordinance, 1907, van die Oranje-Vrystaat, [voorsiening gemaak is] ingestel is; en”; en
- 10 (b) deur subartikel (2) deur die volgende subartikel te vervang:
 “(2) Behoudens die bepalings van artikel 2, berus, vanaf die datum in 'n kragtens subartikel (1) van hierdie artikel uitgereikte proklamasie genoem, al die bates en regte van die Bestuurskomitees by, en gaan al hul laste en verpligtings oor op, [in buitestedelike bestuur wat ingevolge genoemde Ordonnansie op Kleinhoeves, 1954, beheer uitoefen oor die gebiede] die betrokke besproeiingsraad wat vir 'n gebied genoem in subartikel (1) (a) van hierdie artikel ingestel is.”.

Wysiging van artikel 3A van Wet 53 van 1966, soos ingevoeg deur artikel 1 van Wet 38 van 1990

- 25 2. Artikel 3A van die Hoofwet word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:
 “(1) Die eiendomsreg oor daardie gedeeltes van die gemeenskaplike weiveld van die [Landbounedersetting] Landbounedersettings Roodepoort en Weltevreden wat nie in persele verdeel is nie, berus by die Staat.”.

3. Section 4 of the principal Act is hereby repealed.

Substitution of section 5 of Act 53 of 1966, as substituted by section 2 of Act 38 of 1990

4. The following section is hereby substituted for section 5 of the principal Act:

"Compensation in respect of rights vesting in State

5. No compensation shall be payable in respect of any rights vesting in the State by virtue of the provisions of section 2 or 3A [or 4]."

Short title and commencement

5. This Act shall be called the Roodepoort and Weltevreden Agricultural Settlements Adjustment Amendment Act, 1991, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*. 10
