AMENDMENT ACT, 1991****GENERAL EXPLANATORY NOTE:**

ACT

To amend the Universities and Technikons Advisory Council Act, 1983, so as to provide for the establishment of an executive committee of the Advisory Council; and to provide for matters connected therewith.

(Assented to 18 March 1991.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 99 of 1983, as amended by section 1 of Act 57 of 1985

1. Section 1 of the Universities and Technikons Advisory Council Act, 1983 (hereinafter referred to as the principal Act), is hereby amended by the insertion after the definition of "Advisory Council" of the following definition:

"executive committee" means the executive committee of the Advisory Council established under section 4 (1);".

Substitution of section 4 of Act 99 of 1983

2. The following section is hereby substituted for section 4 of the principal Act: 10

"Executive committee and other committees of Advisory Council

4. (1) (a) The Advisory Council may establish an executive committee to dispose of such matters with regard to the functions of the Advisory Council as are of an urgent nature, as may be determined by the Advisory Council from time to time, except such matters as may be indicated by the Minister.

(b) The executive committee shall consist of—

- (i) the chairman of the Advisory Council;
- (ii) the person appointed by the Minister to the Advisory Council in terms of section 2 (c); and
- (iii) a member of the Advisory Council designated by it.

(c) A member of the executive committee shall vacate his office—

- (i) if he resigns as a member of the executive committee;
- (ii) if he vacates his office on the Advisory Council;
- (iii) in the case of a member designated by the Advisory Council in terms of paragraph (b) (iii), if the Advisory Council so decides.

(d) A decision of the executive committee shall be deemed to be a decision of the Advisory Council: Provided that matters disposed of by the executive committee shall be included in the agenda of the next succeeding meeting of the Advisory Council for the information of the other members of the Advisory Council.

WET

Tot wysiging van die Wet op die Adviesraad vir Universiteite en Technikons, 1983, ten einde voorsiening te maak vir die instelling van 'n uitvoerende komitee van die Adviesraad; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

Wysiging van artikel 1 van Wet 99 van 1983, soos gewysig deur artikel 1 van Wet 57 van 1985

5 1. Artikel 1 van die Wet op die Adviesraad vir Universiteite en Technikons, 1983 (hieronder die Hoofwet genoem), word hierby gewysig deur na die omskrywing van "technikon" die volgende omskrywing in te voeg:

"uitvoerende komitee" die uitvoerende komitee van die Adviesraad kragtens artikel 4 (1) ingestel;".

10 Vervanging van artikel 4 van Wet 99 van 1983

2. Artikel 4 van die Hoofwet word hierby deur die volgende artikel vervang:

"Uitvoerende komitee en ander komitees van Adviesraad

4. (1) (a) Die Adviesraad kan 'n uitvoerende komitee instel om die sake met betrekking tot die werkzaamhede van die Adviesraad wat van 'n dringende aard is, soos deur die Adviesraad van tyd tot tyd bepaal, uitgesonderd die sake wat deur die Minister aangedui word, af te handel.
- (b) Die uitvoerende komitee bestaan uit—
(i) die voorsitter van die Adviesraad;
(ii) die persoon deur die Minister ingevolge artikel 2 (c) in die Adviesraad aangestel; en
(iii) 'n lid van die Adviesraad deur hom aangewys.
- (c) 'n Lid van die uitvoerende komitee ontruim sy amp—
(i) indien hy as lid van die uitvoerende komitee bedank;
(ii) indien hy sy amp in die Adviesraad ontruim;
(iii) in die geval van 'n lid deur die Adviesraad aangewys ingevolge paragraaf (b) (iii), indien die Adviesraad so besluit.
- (d) 'n Besluit van die uitvoerende komitee word geag 'n besluit van die Adviesraad te wees: Met dien verstande dat sake deur die uitvoerende komitee afgehandel, in die sakelys van die eersvolgende vergadering van die Adviesraad ter inligting van die ander lede van die Adviesraad ingesluit word.

- (2) (a) The Advisory Council may appoint committees to assist it in the performance of its functions, and may designate as members of such committees persons who are not members of the Advisory Council.
(b) The chairman of a committee appointed in terms of paragraph (a) shall be designated by the Advisory Council from among its own members.".

5

Substitution of section 6 of Act 99 of 1983

3. The following section is hereby substituted for section 6 of the principal Act:

"Remuneration and allowances of members of Advisory Council and committees

10

6. A member of the Advisory Council and any person appointed or designated in terms of subsection (1) or (2) of section 4 as a member of a committee who is not in the full-time employment of the State, shall in respect of services rendered by him in connection with the functions of the Advisory Council, out of money voted by Parliament for that purpose, be paid such remuneration, travelling, subsistence and other allowances as the Minister may determine with the concurrence of the Minister of Finance.".

Short title

4. This Act shall be called the Universities and Technikons Advisory Council Amendment Act, 1991.

- (2) (a) Die Adviesraad kan komitees instel om hom by die verrigting van sy werksaamhede by te staan, en kan persone wat nie lede van die Adviesraad is nie as lede van sodanige komitees aanwys.
5 (b) Die voorstander van 'n komitee ingevalle paragraaf (a) aangestel, word deur die Adviesraad uit eie geledere aangewys.”.

Vervanging van artikel 6 van Wet 99 van 1983

3. Artikel 6 van die Hoofwet word hierby deur die volgende artikel vervang:

“Besoldiging en toelaes van lede van Adviesraad en komitees

- 10 6. ’n Lid van die Adviesraad en iemand wat kragtens subartikel (1) of (2) van artikel 4 as lid van ’n komitee aangestel of aangewys is en wat nie heeltjyds in diens van die Staat is nie, moet ten opsigte van dienste deur hom in verband met die werksaamhede van die Adviesraad gelewer, uit geld deur die Parlement vir dié doel bewillig, die besoldiging, reis-, verblyf- en ander toelaes betaal word wat die Minister met die instemming van die Minister van Finansies bepaal.”.
