Act No. 25, 1991**NATIONAL MONUMENTS AMENDMENT ACT, 1991****GENERAL EXPLANATORY NOTE:**

ACT

To amend the National Monuments Act, 1969, so as to authorize the council to pay to certain members of the council, of its committees or of the committees established under section 3A the remuneration determined by the Minister with the concurrence of the Minister of Finance; to authorize the council to pay to members of the council or of such committees allowances so determined; and to grant to the council greater autonomy with regard to the determination of its establishment, and the payment of remuneration, allowances, subsidies and other benefits to its officers and employees; and to provide for incidental matters.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Substitution of section 6 of Act 28 of 1969, as amended by section 6 of Act 13 of 1981

1. The following section is hereby substituted for section 6 of the National Monuments Act, 1969 (hereinafter referred to as the principal Act):

“Remuneration and allowances of members of council and committees

6. The council may pay to a member of the council or any committee thereof or any committee established by section 3A—
(a) who is not in the full-time employment of the State or the council, the remuneration; and
(b) the allowances, determined by the Minister with the concurrence of the Minister of Finance.”

Amendment of section 8 of Act 28 of 1969, as amended by section 6 of Act 35 of 1979

2. Section 8 of the principal Act is hereby amended by the substitution for paragraph (a) of subsection (1) of the following paragraph:

- “(a) (i) The council may appoint such officers and employees as it may deem necessary for the performance of its functions and the carrying out of its duties, and shall determine their remuneration, allowances, subsidies and other benefits in accordance with a system approved by the Minister with the concurrence of the Minister of Finance, as such system is amended from time to time.
(ii) Any person who immediately prior to the commencement of the National Monuments Amendment Act, 1991, was an officer or employee in the employment of the council shall, subject to the provisions

5 1. Artikel 6 van die Wet op Nasionale Gedenkwaardighede, 1969 (hieronder die Hoofwet genoem), word hierby deur die volgende artikel vervang:

"Besoldiging en toelaes van lede van raad en komitees

6. Die raad kan aan 'n lid van die raad of 'n komitee daarvan of 'n komitee ingestel by artikel 3A—

- 10 (a) wat nie in die heeltydse diens van die Staat of die raad is nie, die besoldiging; en
 (b) die toelaes,
betaal wat die Minister met die instemming van die Minister van Finansies bepaal."

15 1. Wysiging van artikel 8 van Wet 28 van 1969, soos gewysig deur artikel 6 van Wet 35 van 1979

2. Artikel 8 van die Hoofwet word hierby gewysig deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:

- 20 "(a) (i) Die raad kan die beampies en werkneemers wat hy nodig ag vir die verrigting van sy werksaamhede en die uitvoering van sy pligte aanstel, en moet hul besoldiging, toelaes, subsidies en ander voordele bepaal ooreenkomsdig 'n stelsel wat die Minister met die instemming van die Minister van Finansies goedkeur, soos daardie stelsel van tyd tot tyd gewysig word.
 (ii) Iemand wat onmiddellik voor die inwerkingtreding van die Wysigingswet op Nasionale Gedenkwaardighede, 1991, 'n beampte of werkneemer in die diens van die raad was, word behoudens die bepalings van

of subparagraph (iii), be deemed to have been appointed as an officer or employee, as the case may be, of the council, as from such commencement.

- (iii) The remuneration, allowances, subsidies and other benefits of any person mentioned in subparagraph (ii) shall not be less favourable than the remuneration, allowances, subsidies and other benefits to which such person was entitled immediately before the commencement of the said Amendment Act.”.

3. This Act shall be called the National Monuments Amendment Act, 1991.
