Act No. 36, 1991 TRANSVAAL BOARD FOR THE DEVELOPMENT OF PERI-URBAN
AREAS ORDINANCE AMENDMENT ACT (TRANSVAAL) (HOUSE
OF ASSEMBLY), 1991

GENERAL EXPLANATORY NOTE:

Words underlined with a solid line indicate insertions in existing enactments.

ACT

To amend the Transvaal Board for the Development of Peri-Urban Areas Ordinance, 1943 (Transvaal) (in so far as it is applied as a law on own affairs of the White population group), so as to make provision for the payment of remuneration and allowances to certain members of a local area committee; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Definition

1. In this Act, unless the context otherwise indicates, "the Ordinance" means the Transvaal Board for the Development of Peri-Urban Areas Ordinance, 1943 (Ordinance No. 20 of 1943) (Transvaal), in so far as and to the extent to which the provisions of Part IV of the Republic of South Africa Constitution Act, 1983 (Act No. 110 of 1983), have by paragraph (a) of Proclamation No. R. 36 of 1989 been declared to be applicable to the said Ordinance. 5

Amendment of section 1 of Ordinance 20 of 1943, as amended by section 1 of Ordinance 24 of 1948 and section 1 of Ordinance 15 of 1966 10

2. Section 1 of the Ordinance is hereby amended by the insertion after the definition of "local authority area" of the following definition:

"Minister" means the Minister in the Ministers' Council of the House of Assembly entrusted with local government affairs;" 15

Amendment of section 21 of Ordinance 20 of 1943, as amended by section 6 of Ordinance 24 of 1948, section 1 of Ordinance 11 of 1958 and section 1 of Ordinance 12 of 1976

3. Section 21 of the Ordinance is hereby amended by the addition of the following subsection: 20

"(5) (a) A member of a local area committee may be paid from the revenue of such committee the remuneration and allowances determined by the Minister with the concurrence of the Minister of the Budget in the Ministers' Council of the House of Assembly.

(b) The remuneration and allowances of members referred to in paragraph (a) may vary according to— 25

- (i) the offices that they hold; and
- (ii) the area for which the local area committee concerned has been established."

Tot wysiging van die Ordonnansie op die Transvaalse Raad vir die Ontwikkeling van Buitestedelike Gebiede, 1943 (Transvaal) (vir sover dit as 'n wet oor die sake van die Blanke bevolkingsgroep toegepas word), ten einde voorsiening te maak vir die betaling van vergoeding en toelaes aan sekere lede van 'n plaaslike gebiedskomitee; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

Woordomscriwing

1. In hierdie Wet, tensy uit die samehang anders blyk, beteken “die Ordonnansie”
5 die Ordonnansie op die Transvaalse Raad vir die Ontwikkeling van Buitestedelike Gebiede, 1943 (Ordonnansie No. 20 van 1943) (Transvaal), vir sover en in die mate waarin die bepalings van Deel IV van die Grondwet van die Republiek van Suid-Afrika, 1983 (Wet No. 110 van 1983), by paragraaf (a) van Proklamasie No. R.36 van 1989 op genoemde Ordonnansie van toepassing verklaar is.

10 Wysiging van artikel 1 van Ordonnansie 20 van 1943, soos gewysig deur artikel 1 van Ordonnansie 24 van 1948 en artikel 1 van Ordonnansie 15 van 1966

2. Artikel 1 van die Ordonnansie word hierby gewysig deur die volgende omskrywing na die omskrywing van “gesondheidskomitee” in te voeg:

15 “‘Minister’ die Minister in die Ministersraad van die Volksraad belas met plaaslike bestuursaangeleenthede;”.

Wysiging van artikel 21 van Ordonnansie 20 van 1943, soos gewysig deur artikel 6 van Ordonnansie 24 van 1948, artikel 1 van Ordonnansie 11 van 1958 en artikel 1 van Ordonnansie 12 van 1976

20 3. Artikel 21 van die Ordonnansie word hierby gewysig deur die volgende subartikel by te voeg:

- “(5) (a) Aan 'n lid van 'n plaaslike gebiedskomitee kan uit die inkomste van sodanige komitee die vergoeding en toelaes betaal word wat die Minister met die instemming van die Minister van Begroting in die Ministersraad van die Volksraad bepaal.
- 25 (b) Die vergoeding en toelaes van lede bedoel in paragraaf (a) kan verskil na gelang van—
- (i) die ampte wat hulle beklee; en
 - (ii) die gebied waarvoor die betrokke plaaslike gebiedskomitee ingestel is.”.

TRANSVAAL BOARD FOR THE DEVELOPMENT OF PERI-URBAN
AREAS ORDINANCE AMENDMENT ACT (TRANSVAAL) (HOUSE
OF ASSEMBLY), 1991**Short title and commencement**

4. (1) This Act shall be called the Transvaal Board for the Development of Peri-Urban Areas Ordinance Amendment Act (Transvaal) (House of Assembly), 1991, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*.

(2) Notwithstanding the provisions of subsection (1), section 3 shall be deemed to have come into operation on 1 July 1990.
