NOTICE OF TEMPORARY IMMUNITY UNDER  
THE INDEMNITY ACT, 1990 (ACT No. 35 OF  
1990)

NOTICE BY THE STATE PRESIDENT OF THE  
REPUBLIC OF SOUTH AFRICA

Whereas I am of the opinion that it is necessary for the promotion of peaceful constitutional solutions in South Africa, I hereby under the power vested in me by section 1 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), unconditionally grant to Bonisile Philemon Norushe immunity as referred to in section 1 (2) of the aforementioned Act for the period from the date of this notice up to and including 30 April 1991.

Given under my Hand and the Seal of the Republic of South Africa at Cape Town this Seventh day of April, One thousand Nine hundred and Ninety-one.
