DIAMONDS ACT, 1986
(ACT No. 56 OF 1986)

LEVIES

Under the powers vested in me by section 93 of the Diamond Act, 1986 (Act No. 56 of 1986), I, George Shepstone Bartlett, Minister of Mineral and Energy Affairs, hereby impose the following levies in respect of producers and licensees who export unpolished diamonds, excluding synthetic diamonds and diamonds not won or found within the Republic, from the Republic:

(a) If those diamonds are exported by the Diamond Purchasing and Trading Company (Pty) Ltd or any other subsidiary or associated company in the De Beers Group, a levy of 0,34 per cent of the fair market value of those diamonds as referred to in section 66 of the said Act; and

(b) if those diamonds are exported by any producer or licensee other than a producer or licensee referred to in paragraph (a), a levy of 0,19 per cent of such fair market values of those diamonds.

Such levies are payable from 1 April 1991 and shall be paid to the South African Diamond Board on the date on which the relevant diamonds are registered for export in terms of the said Act.

Government Notice No. 657 of 7 April 1989 is hereby repealed with effect from 1 April 1991.
