ACT

To amend the Public Service Act, 1984, so as to empower the State President to amend Schedule 1 and Schedule 2 to that Act with retrospective effect; and to shorten the period within which heads of departments have to be notified of the extension or non-extension of their period of office; and to provide for matters connected therewith.

(Assented to 14 May 1991.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Amendment of section 6 of Act 111 of 1984, as amended by section 1 of Act 22 of 1986

1. (1) Section 6 of the Public Service Act, 1984, is hereby amended by the substitution for subsection (3) of the following subsection: 5

“(3) The State President may, after the Commission has made a recommendation, amend Schedule 1 and Schedule 2 by proclamation in the *Gazette*, and, if he deems it necessary, with retrospective effect up to the date of the recommendation of the Commission.”. 10

(2) Subsection (1) of this section shall be deemed to have come into operation on 1 January 1985.

Amendment of section 11 of Act 111 of 1984

2. Section 11 of the Public Service Act, 1984, is hereby amended by the substitution in subsection (2) for paragraph (a) of the following paragraph: 15

“(a) The Minister or Administrator shall in writing inform the officer concerned at least **[six]** two calendar months before the expiry of the term contemplated in paragraph (a) or (b) or any previously extended term contemplated in paragraph (c), of his intention to retain him in service for an extended term, or not.”. 20

3. This Act shall be called the Public Service Amendment Act, 1991.

Tot wysiging van die Staatsdienswet, 1984, ten einde die Staatspresident te magtig om Bylae 1 en Bylae 2 by dié Wet met terugwerkende krag te wysig; en die tydperk waarin departementshoofde kennis van die verlenging of nie-verlenging van hul ampstermyn gegee moet word, te verkort; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

Wysiging van artikel 6 van Wet 111 van 1984, soos gewysig deur artikel 1 van Wet 22 van 1986

- 5 1. (1) Artikel 6 van die Staatsdienswet, 1984, word hierby gewysig deur subartikel (3) deur die volgende subartikel te vervang:
- “(3) Die Staatspresident kan, nadat die Kommissie ’n aanbeveling gedoen het, Bylae 1 en Bylae 2 by proklamasie in die *Staatskoerant* wysig, en, indien hy dit nodig ag, met terugwerkende krag tot die datum van die aanbeveling van die Kommissie.”
- 10 (2) Subartikel (1) van hierdie artikel word geag op 1 Januarie 1985 in werking te getree het.

Wysiging van artikel 11 van Wet 111 van 1984

2. Artikel 11 van die Staatsdienswet, 1984, word hierby gewysig deur in
- 15 subartikel (2) paragraaf (a) deur die volgende paragraaf te vervang:
- “(a) Die Minister of Administrateur moet die betrokke beampte minstens **[ses]** twee kalendermaande voor die verstryking van die termyn in paragraaf (a) of (b) of enige voorheen verlengde termyn in paragraaf (c) bedoel, skriftelik meedeel of hy van voorneme is om hom vir ’n verlengde termyn
- 20 in diens te hou, al dan nie.”

3. Hierdie Wet heet die Staatsdienswysigingswet, 1991.
