**ACT**

**To amend the Education and Training Act, 1979, so as to provide that the language to be used as a medium of instruction at a school shall be determined by the Minister after consultation with the parents of the pupils enrolled at that school; and to further provide for the rendering of health services at certain schools; and to provide for incidental matters.**

(Afrikaans text signed by the State President.)  
(Assented to 27 June 1991.)

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

**Amendment of section 3 of Act 90 of 1979, as amended by section 3 of Act 35 of 1989**

1. (1) Section 3 of the Education and Training Act, 1979 (hereinafter referred to as the principal Act), is hereby amended by the substitution for paragraph (b) of the following paragraph:

“(b) that the language or languages to be used as the medium of instruction at a school and the extent and duration of such use shall be determined by the Minister after consultation by him in the prescribed manner with the parents of the pupils enrolled at that school;”.

(2) The principle which immediately prior to the commencement of subsection (1) applied in terms of paragraph (b) of section 3 of the Education and Training Act, 1979 (Act No. 90 of 1979), in respect of the language used as the medium of instruction at a particular school, shall, notwithstanding the commencement of subsection (1), continue to apply to that school until it is superseded by a determination made in terms of the said paragraph as substituted by subsection (1).

**Amendment of section 41 of Act 90 of 1979, as amended by section 5 of Act 35 of 1989**

2. Section 41 of the principal Act is hereby amended by the substitution for subsection (1) of the following subsection:

“(1) The Director-General of a provincial administration may in consultation with the [provincial secretary of a provincial administration] Director-General [cause] render health services [to be rendered] at public schools and State-aided schools and hostels attached to such schools.”.

**Tot wysiging van die Wet op Onderwys en Opleiding, 1979, ten einde voorsiening te maak dat die taal wat as medium van onderrig by 'n skool gebruik word, deur die Minister na oorleg met die ouers van leerlinge wat by daardie skool ingeskryf is, bepaal word; en verdere voorsiening te maak vir die verskaffing van gesondhedsdienste by sekere skole; en om vir bykomstige aangeleenthede voorsiening te maak.**

**D**AAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

**Wysiging van artikel 3 van Wet 90 van 1979, soos gewysig deur artikel 3 van Wet 35 van 1989**

5 · 1. (1) Artikel 3 van die Wet op Onderwys en Opleiding, 1979 (hieronder die Hoofwet genoem), word hierby gewysig deur paragraaf (b) deur die volgende paragraaf te vervang:

10 “(b) dat die taal of tale wat as die medium van onderrig by 'n skool gebruik moet word en die omvang en duur van sodanige gebruik, deur die Minister bepaal word nadat hy op die voorgeskrewe wyse met die ouers van die leerlinge wat by daardie skool ingeskryf is, oorleg gepleeg het;”.

15 (2) Die beginsel wat onmiddellik voor die inwerkingtreding van subartikel (1) ingevolge paragraaf (b) van artikel 3 van die Wet op Onderwys en Opleiding, 1979 (Wet No. 90 van 1979), gegeld het ten opsigte van die taal wat as medium van onderrig by 'n bepaalde skool gebruik word, bly ondanks die inwerkingtreding van subartikel (1) op daardie skool van toepassing totdat dit vervang word deur 'n bepaling wat gemaak is kragtens genoemde paragraaf soos vervang deur subartikel (1).

**Wysiging van artikel 41 van Wet 90 van 1979, soos gewysig deur artikel 5 van Wet 35 van 1989**

2. Artikel 41 van die Hoofwet word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

25 “(1) Die Direkteur-generaal van 'n provinsiale administrasie kan in oorleg met die provinciale sekretaris van 'n provinsiale administrasie Direkteur-generaal gesondhedsdienste in openbare skole en Staatsondersteunde skole en koshuise verbonde aan sodanige skole, [laat] lewer.”.

**Short title and commencement**

- 3.** (1) This Act shall be called the Education and Training Amendment Act, 1991, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*.  
 (2) Different dates may be so fixed in respect of different provisions of this Act. 5
