NOTICE BY THE STATE PRESIDENT OF THE
REPUBLIC OF SOUTH AFRICA

NOTICE OF INDEMNITY IN TERMS OF THE
INDEMNITY ACT, 1990 (ACT No. 35 OF 1990)

Under the powers vested in me by section 2 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), and with due consideration to the recommendation of the Indemnity Committee appointed in terms of regulation 2 (1) of the Regulations in terms of the Indemnity Committees, I hereby unconditionally grant the indemnity referred to in section 2 (2) of the said Act to Jacob Mpsa Rapholo, born 7 June 1960, in respect of the events upon which the charges in the Northern Circuit Local Division of the Supreme Court of South Africa, held at Pietersburg, are founded, with the exception of the events in respect of—

- (a) the murder of Nicolaas Cornelius Claassen;
- (b) the attempted murder of Willem Johannes Jacobus van Rooyen;
- (c) the attempted murder of Otto Bousema van Dyk; and
- (d) the attempted murder of Franci Phillip Vorster.
