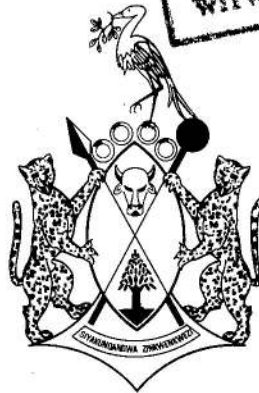

It is hereby notified that the Chairman of the Council of State has assented to the following decree which is hereby published for general information: -

**NEWSPAPER AND IMPRINT REGISTRATION AMENDMENT DECREE, 1991
DECREE No. 19 OF 1991.**

NEWSPAPER AND IMPRINT REGISTRATION AMENDMENT DECREE, 1991

DECREE

[English text signed by the Chairman of the Council of State. Assented to on 12 September 1991.]

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

1. Amendment of Section 1 of Act 63 of 1971. - Section 1 of the Newspaper Imprint and Registration Act, 1971 (hereinafter referred to as the principal Act) is hereby amended -

- (a) by the insertion before the definition of "Minister" of the following definition:-
" 'Director-General' means the Director-General of the Department of Internal Affairs and Land Tenure;";
- (b) by the substitution for the definition of "Minister" of the following definition:
" 'Minister' means the Minister of Internal Affairs and Land Tenure.";
- (c) by the substitution for the definition of "Republic" of the following definition:-
" 'Republic' means the Republic of Ciskei;"; and
- (d) by the deletion of the definition of "Secretary".

2. Amendment of Section 8 of Act 63 of 1971. - Section 8 of the principal Act is hereby amended by the substitution for the words "resident in the Republic" of the words "resident in Ciskei or in the Republic of South Africa or in any other territory which previously formed part of the Republic of South Africa".

3. Insertion of Section 8A in Act 63 of 1971. - The following section is hereby inserted in the NEWSPAPER AND IMPRINT REGISTRATION AMENDMENT DECREE, 1991.

Chapter II of the principal Act after Section 8:

"8A. Minister may withdraw registration of newspaper. - (1) Notwithstanding anything in this Act or in any other law contained but subject to the provisions of subsection (2), the Minister may by notice in the *Gazette* withdraw the registration of any newspaper which is or is deemed to be registered in Ciskei if, in his opinion, the publication of such newspaper in Ciskei is not in the interests of the State or of the public in general.

(2) The Minister shall not withdraw the registration of any newspaper unless and until he has in writing called upon the holder of the Certificate of Registration of such newspaper to show cause, also in writing within a reasonable period (not exceeding seven days), why the registration of such newspaper should not be withdrawn and has duly considered any representations which such holder has made to him in the matter.

(3) The decision of the Minister shall be conveyed to the aforementioned holder of the Certificate of Registration in writing.

(4) Upon the publication of any notice in terms of subsection (2) the Certificate of Registration of the newspaper shall, in so far as it appears or is deemed to apply to the Republic of Ciskei, be deemed to be cancelled.

4. Repeal of Section 14 of Act 63 of 1971. - Section 14 of the principal Act is hereby repealed.

5. Substitution of certain word. - Subject to the foregoing provisions of this decree, the principal Act is hereby amended by the substitution for the word "Secretary", whenever it occurs, of the word "Director-General".

6. Short title. - This Decree shall be called Newspaper and Imprint Registration Amendment Decree, 1991.
