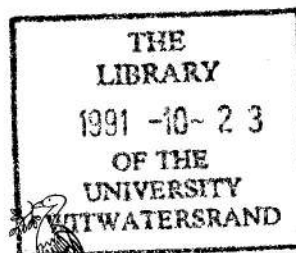

REPUBLIC OF CISKEI CONSTITUTION AMENDMENT DECREE, 1991

DECREE

To amend the Republic of Ciskei Constitution Decree, to provide for the appointment of a Deputy Chairman of the Council of State, and incidental matters.

[English text signed by the Chairman of the Council of State. Assented to on 12 September 1991.]

1. Substitution of Section 14 of Decree No. 45 of 1990. - The following section is hereby substituted for Section 14 of the Republic of Ciskei Constitution Decree, 1990 (hereinafter referred to as the principal Decree).

"14. Deputy Chairman

- (1) The Chairman shall appoint a Deputy Chairman who shall be a member of the Council of State.
- (2) The Deputy Chairman shall, at any time when the Chairman is indisposed or otherwise temporarily unable to perform the duties of his office, act as Chairman during the pleasure of the Chairman.
- (3) If the office of the Chairman becomes vacant or the Chairman for any reason becomes permanently incapable of carrying out the duties of his office, the Deputy Chairman shall forthwith assume the office of the Chairman."

2. Amendment of Section 15 of Decree No. 45 of 1990. - Section 15 of the principal Decree is hereby amended by the deletion of the words between the words "person" and "be" and the substitution therefore of the words "about to assume office".

3. Short title. - This Decree shall be called the Republic of Ciskei Constitution Amendment Decree, 1991.
