AMENDMENT OF SCHEDULES 1 AND 2 TO THE PUBLIC SERVICE ACT, 1984 (ACT No. 111 OF 1984)

Under the powers vested in me by section 6 (3) of the Public Service Act, 1984 (Act No. 111 of 1984), I hereby amend, in accordance with the recommendation of the Commission for Administration, Schedule 1 to the said Act with effect from 1 November 1991, by the substitution of the words "Department of Public Works" and "Director-General: Public Works" for the words "Department of Public Works and Land Affairs" and "Director-General: Public Works and Land Affairs", where they appear in columns I and II respectively; as well as by the deletion of the words "Department of Planning, Provincial Affairs and National Housing" and "Director-General: Planning, Provincial Affairs and National Housing", where they appear in columns I and II, respectively, and the insertion of the words "Department of Local Government and National Housing" and "Director-General: Local Government and National Housing" after the words "Department of Justice" and "Director-General: Justice" and the words "Department of Regional and Land Affairs" and "Director-General: Regional and Land Affairs" after the words "Department of Public Works" and "Director-General: Public Works", where they appear in columns I and II, respectively.

Under the above-mentioned powers vested in me, I hereby also amend, in accordance with the recommendation of the Commission for Administration, Schedule 2 to the said Act with effect from 1 November 1991, by the deletion of the words "Office for Regional Development" and "Head: Office for Regional Development", where they appear in columns I and II, respectively.
