NOTICE BY THE STATE PRESIDENT OF THE

NOTICE OF INDEMNITY IN TERMS OF THE INDEM-
NITY ACT, 1990 (ACT No. 35 OF 1990)

Under the powers vested in me by section 2 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), I hereby unconditionally grant the indemnity referred to in section 2 (2) of the said Act to Khulekani Mthimkulu, born 1 January 1969, Nkululeko Mthimkulu, born 3 February 1970, Musa Mpanza, born 8 July 1969, and Mondli Shezi, born 1 February 1974, in respect of the events upon which the charge of possession of explosives in contravention of section 28 (1) of the Explosives Act, 1956 (Act No. 26 of 1956), in Case No. 92/91 in the Regional Court at Empangeni is based.
