WET

Om die Wet op Steenkoolhulpbronne, 1985, te herroep; om die Wet op Prysbeheer, 1964, te wysig ten einde 'n verwysing daarin na eersgenoemde Wet te skrap; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Herroeping van Wet 60 van 1985

1. Die Wet op Steenkoolhulpbronne, 1985 (Wet No. 60 van 1985), word hierby herroep. 5

Wysiging van artikel 1 van Wet 25 van 1964, soos gewysig deur artikel 1 van Wet 80 van 1967, artikel 1 van Wet 39 van 1976 en artikel 17 van Wet 60 van 1985

2. Artikel 1 van die Wet op Prysbeheer, 1964 (Wet No. 25 van 1964), word hierby gewysig deur die omskrywing van "goedere" deur die volgende omskrywing te vervang: 10

"goedere" ook gebruikte goedere **[maar nie ook steenkool soos omskryf in die Wet op Steenkoolhulpbronne, 1985, nie];".**

3. Hierdie Wet heet die Wet tot Herroeping van die Wet op Steenkoolhulpbronne, 1992. 15

ACT

To repeal the Coal Resources Act, 1985; to amend the Price Control Act, 1964, so as to delete a reference therein to the first-mentioned Act; and to provide for matters connected therewith.

*(English text signed by the State President.)
(Assented to 3 March 1992.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Repeal of Act 60 of 1985

1. The Coal Resources Act, 1985 (Act No. 60 of 1985), is hereby repealed.
- 5 Amendment of section 1 of Act 25 of 1964, as amended by section 1 of Act 80 of 1967, section 1 of Act 39 of 1976 and section 17 of Act 60 of 1985
 2. Section 1 of the Price Control Act, 1964 (Act No. 25 of 1964), is hereby amended by the substitution for the definition of “goods” of the following definition:
 - 10 “‘goods’ includes used goods [but excludes coal as defined in section 1 of the Coal Resources Act, 1985];”.

Short title

3. This Act shall be called the Coal Resources Act Repeal Act, 1992.

ACT

To repeal the Cost Resources Act, 1982; to amend the Price Control Act, 1981, so as to delete a reference therein to the first-meeting Act; and to provide for matters connected therewith.

BE IT ENACED by the State President and the Parliament of the Republic of South Africa, as follows:

Repeal of Act No. 60 of 1982

1. The Cost Resources Act, 1982 (Act No. 60 of 1982), is hereby repealed.

2. Amendment of section 1 of Act 32 of 1981, as amended by section 1 of Act 80 of 1982, section 1 of Act 36 of 1982 and section 12 of Act 60 of 1982.

3. Section 1 of the Price Control Act, 1981 (Act No. 32 of 1981), is hereby superseded by the substitution of "goods" for "commodities" in section 1 of the following definitions:

10. "goods" includes any goods [not otherwise cost as defined in section 1 of the Cost Resources Act, 1982].

Significant

3. This Act shall be called the Cost Resources Act Repeal Act, 1983.
