**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

**Amendment of section 13 of Act 78 of 1977, as amended by section 8 of Act 77 of 1990**

- 5    **1.** Section 13 of the Urban Transport Act, 1977, is hereby amended by the substitution in the Afrikaans text for paragraph (f) of subsection (1) of the following paragraph:
- 10            “(f) hoogstens **[twee]** drie lede benoem deur die liggame wat na die mening van die betrokke Administrateur verteenwoordigend is van openbare vervoeroperateurs, met inbegrip van openbare vervoeroperateurs wat passasiers in die betrokke stedelike ver-voergebied vir huur of beloning vervoer;”.
