DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Bewilliging van geld vir behoeftes van Departement

1. Behoudens die bepalings van die Poswet, 1958 (Wet No. 44 van 1958), word daar hierby bewillig, ten laste van die Poskantoorfonds, vir die behoeftes van die Departement van Pos- en Telekommunikasiewese ten opsigte van die boekjaar wat op 31 Maart 1993 eindig, die bedrae geld in die Bylae uiteengesit. 5

Doeleindes waarvoor geld aangewend moet word

2. Die geld by artikel 1 bewillig, moet aangewend word vir die doeleindes uiteengesit in die Bylae en nader omskryf in die Begroting van Inkomste en Uitgawe van die Departement van Pos- en Telekommunikasiewese (R.P. 15—1992), soos aan die Parlement voorgelê en deur hom goedgekeur. 10

Beperking op oorskryding van sekere bewilligde bedrae

3. Ondanks die bepalings van artikel 12F(3) en (4) van die Poswet, 1958 (Wet No. 44 van 1958), mag 'n bedrag wat by hierdie Wet bewillig is vir persoonlike onthaalvoorsiening nie anders as ooreenkomstig 'n magtiging kragtens artikel 12F(5)(a) van die Poswet, 1958, verleen, oorskry word nie. 15

4. Hierdie Wet heet die Poskantoorbegrotingswet, 1992.

ACT

To appropriate a sum of money for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending 31 March 1993.

(Assented to 7 April 1992.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Appropriation of moneys for requirements of Department

1. Subject to the provisions of the Post Office Act, 1958 (Act No. 44 of 1958), there are hereby appropriated, as a charge to the Post Office Fund, for the requirements of the Department of Posts and Telecommunications in respect of the financial year ending 31 March 1993, the sums of money set forth in the Schedule.

Purposes to which moneys shall be applied

- 10 2. The moneys appropriated by section 1 shall be applied to the purposes set forth in the Schedule and more particularly specified in the Estimates of Revenue and Expenditure of the Department of Posts and Telecommunications (R.P. 15—1992), as submitted to and approved by Parliament.

Limitation on exceeding of certain appropriated amounts

- 15 3. Notwithstanding the provisions of section 12F(3) and (4) of the Post Office Act, 1958 (Act No. 44 of 1958), an amount appropriated by this Act to provide for personal entertainment may not be exceeded otherwise than in accordance with an authority granted under section 12F(5)(a) of the Post Office Act, 1958.

Short title

- 20 4. This Act shall be called the Post Office Appropriation Act, 1992.
