**D**AAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

**Geldigverklaring van sekere ongemagtige uitgawe**

1. (1) Uitgawe ten bedrae van R650 000 wat gedurende die boekjaar 1987-88 deur die voormalige Departement van Landbou-ekonomie en -bemarking aangegaan is in verband met die afskaffing van die Leslie- en Bultfontein-gevangenisbuiteposte word hierby geldig verklaar, en die Staatsinkomsterekkening word hierby met daardie uitgawe belas.

(2) Die uitgawe in subartikel (1) vermeld, word nader omskryf in paragraaf 11(2) op bladsy 11 van die Verslag van die Ouditeur-generaal oor die Appropriasie- en Diverse Rekenings ten opsigte van Algemene Sake vir 1987-88 [RP 111/88], wat aan die Parlement voorgelê is, en in die Verslag van die Gesamentlike Komitee oor Openbare Rekenings vir 1989 asook sy Vierde Verslag vir 1990.

# ACT

**To validate certain unauthorized expenditure incurred by the former Department of Agricultural Economics and Marketing, and to charge the State Revenue Account with such expenditure.**

*(Afrikaans text signed by the State President.)  
(Assented to 26 April 1992.)*

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

**Validation of certain unauthorized expenditure**

1. (1) Expenditure to the amount of R650 000 incurred by the former 5 Department of Agricultural Economics and Marketing during the 1987-88 financial year in connection with the abolition of the Leslie and Bultfontein prison outposts is hereby validated, and the State Revenue Account is hereby charged with such expenditure.  
(2) The expenditure referred to in subsection (1) is more fully described in 10 paragraph 11(2) on page 11 of the Report of the Auditor-General on the Appropriation and Miscellaneous Accounts in respect of General Affairs for 1987-88 [RP 111/88], which has been submitted to Parliament, and in the Report of the Joint Committee on Public Accounts for 1989 as well as its Fourth Report for 1990.

**15 Short title**

2. This Act shall be called the Validation of Unauthorized Expenditure Act, 1992.
