PUBLICATIONS OR OBJECTS CONDITIONS

A Committee of Publications referred to in section 4 of the Publications Act, 1974 (the Act), in accordance with section 11 of the Act has decided that the under-mentioned publications are not undesirable within the meaning of section 47 (2) of the Act, subject to conditions—

that the publication may not knowingly be sold, hired or lent out by lending libraries to persons under the age of 18 years; and

that the publication for purposes of distribution may only be displayed and distributed in a sealed plastic wrapping; and

that the publication may only be distributed in bookshops and lending libraries and by wholesale book distributors.
