ABROGATION OF PROHIBITION ON FIRES IN THE OPEN AIR AND ON THE BURNING OF SLASH

Under and by virtue of the powers vested in me by section 25 (1) and 25 (2) of the Forest Act, 1984 (Act No. 122 of 1984), to publish prohibition notices on the making of fires in the open air and the burning of slash by publication of a notice in the *Government Gazette*, I hereby abrogate the prohibition as published in Government Notice No. 3314 dated 7 December 1992, with reference to—

Notice No. 2053 in respect of the Districts of Letaba and Pietersburg, dated 24 July 1992, published in *Government Gazette* No. 14167 of 24 July 1992 in as far as it pertains to the prohibition on fires in the open air;

Notice No. 1295 in respect of the Pietersburg District, dated 8 May 1992, published in the *Government Gazette* No. 13968 of 8 May 1992 in as far as it pertains to the prohibition on the burning of slash; and

Notice No. 1652 in respect of the Soutpansberg District, dated 19 June 1992, published in *Government Gazette* No. 14048 of 19 June 1992 in as far as it pertains to the prohibition on fires in the open air.
