

ASSIGNMENT OF THE ADMINISTRATION OF CERTAIN PROVISIONS OF THE SEA FISHERY ACT, 1988 (ACT NO. 12 OF 1988), AND THE REGULATIONS MADE UNDER SECTION 45 OF THAT ACT, TO THE ADMINISTRATORS OF THE PROVINCES OF THE CAPE OF GOOD HOPE AND NATAL

Under section 15 (1) of the Provincial Government Act, 1986 (Act No. 69 of 1986)—

(a) I hereby assign the administration of the provisions of sections 4 (1) and (2) in so far as it concerns the administration of a provision which is assigned in this Proclamation to an Administrator, 5 (1), (2), (3) and (4), 26, 44 in so far as it concerns the administration of a provision which is assigned in this Proclamation to an Administrator, sections 45 (1) (h), (i), (j) and (k) and 46 (b) of the Sea Fishery Act, 1988 (Act No. 12 of 1988)—in this Proclamation referred to as “the Act”—and the provisions of regulation 127 (1) and (2) of the regulations published by Government Notice No. R. 2934 of 23 October 1992 as amended by Government Notice No. R. 3248 of 27 November 1992 and Government Notice No. R. 5 of 8 January 1993—in this Proclamation referred to as “the regulations”—in so far as those provisions confer, impose or entrust powers, duties and functions to the Minister of Environment Affairs—in this Proclamation referred to as “the Minister”—to the Administrators of the Provinces of the Cape of Good Hope and Natal;

- (b) I hereby determine that for the purpose of the administration of the assignment referred to in paragraph (a), a reference in the Act or the regulation in this Proclamation to "the Minister", "the Department" or "the *Gazette*", shall be construed as a reference to the Administrator, the Provincial Administration or the *Official Gazette*, as the case may be, of the province concerned;
- (c) I hereby determine with a view to the effective exercise, carrying out or performance of the powers, duties and functions mentioned in sections 4 (3), 5 (5), 6, 44 and 49 of the Act, and regulation 127 of the regulations mentioned in the assignment in paragraph (a), the expression "director-general", where it appears in any mentioned section or regulation, be construed as a reference to the Director-General of the Provincial Administration of the Province concerned; and
- (d) I determine that this Proclamation shall come into operation on **1 March 1993**.

ASSIGNMENT OF THE ADMINISTRATION OF CERTAIN PROVISIONS OF THE SEABIRDS AND SEALS PROTECTION ACT, 1973 (ACT NO. 46 OF 1973), TO THE ADMINISTRATORS OF THE PROVINCES OF THE CAPE OF GOOD HOPE AND NATAL

Under section 15 (1) of the Provincial Government Act, 1986 (Act No. 69 of 1986)—

- (a) I hereby assign the administration of the provisions of—
- (i) section 2 (1) (a) with regard to seabirds and products of seabirds, except on an island specified in Schedule 2 and in respect of South African citizens in Antarctica;
  - (ii) section 2 (1) (b), except the islands specified in Schedule 2;
  - (iii) section 2 (2) (a) and (2) (c), in respect of products of seabirds;
  - (iv) sections 4, 5, 6, 8 and 9, in respect of seabirds and products of seabirds;
  - (v) section 10, except the islands specified in Schedule 2; and
  - (vi) section 11 (1) (a), (cA), (d), (e) and (f) and 11 (2) with regard to seabirds and products of seabirds,

- (c) I determine that this Proclamation shall come into operation on **1 March 1993**.

ASSIGNMENT OF THE ADMINISTRATION OF CERTAIN PROVISIONS OF THE FOREST ACT, 1984 (ACT NO. 122 OF 1984), AND THE REGULATIONS MADE UNDER SECTION 73 OF THAT ACT, TO THE ADMINISTRATOR OF THE PROVINCE OF NATAL

Under section 15 (1) of the Provincial Government Act, 1986 (Act No. 69 of 1986)—

- (a) I hereby assign the administration of the provisions of sections 4 (1), 10 (1), (2) and (3), 11 (1), 15 (1), (2), (3) and (4), 73 (1) (a) (i), (ii), (iii), (v), (vi), (vii), (viii), (ix), (x), (xi), (xii), (xiii), (xiv), (xv), (xvi), (xvii) and (xviii), (b), (h) and (i) and (2), 74 (a) and (b) and 87A of the Forest Act, 1984 (Act No. 122 of 1984)—in this Proclamation referred to as “the Act”—and the provisions of regulations 7 (1) and (3), 9 (5), 10 (4), 11 (4), (5) (a) and (6) (c) and 14 (1) (b) and (c) of the regulations published by Government Notice No. R. 602 of 27 March 1986, and amended by Government Notices Nos. R. 1080 of 18 May 1990, R. 2264 of 28 September 1990 and R. 1717 of 26 July 1991—in this Proclamation referred to as “the regulations”—in so far as those provisions confer, impose or entrust powers, duties and functions to the Minister of Water Affairs and Forestry, in this Proclamation referred to as “the Minister”—

in respect of the unsurveyed State land known as Dukuduku State Forest, in extent approximately 3 207 hectares, and situated in the Province of Natal north of the Mtubatuba/St Lucia Road, to the Administrator of the Province of Natal;

- (c) I hereby determine with a view to the effective exercise, carrying out or performance of the powers, duties and functions mentioned in sections 4 (2), 5, 6, 11, 12, 14, 15, 81 and 85 of the Act, and in regulations 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 20, 21 and 40 of the regulations with reference to the State forest mentioned in the assignment in paragraph (a), the expression "Director-General", where it appears in any mentioned section or regulation, be construed as a reference to the Director-General of the Provincial Administration of Natal; and
- (d) I determine that this Proclamation shall come into operation on **27 February 1993**.
