FINANCIAL MARKETS CONTROL ACT, 1989

EXEMPTION FROM APPLICATION OF FINANCIAL MARKETS CONTROL ACT, 1989

I, Petrus Johannes Badenhorst, Registrar of Financial Markets, hereby under section 40 (2) of the Financial Markets Control Act, 1989 (Act No. 55 of 1989), exempt, with effect from 16 July 1993, subject to the conditions set out in the Schedule, until 30 April 1994, the Bond Market Association of 1 Kerk Street, Johannesburg, and all its members from time to time, from all the provisions of the Financial Markets Control Act, 1989, excluding sections 20, 21, 22 and 23 and 36 (1) (a), in so far as they relate to the said sections 20, 21 and 22.

SCHEDULE

CONDITIONS OF EXEMPTION IMPOSED UNDER SECTION 40 (2) OF THE FINANCIAL MARKETS CONTROL ACT, 1989 (ACT NO. 55 OF 1989)

1. (1) In this Schedule, unless the context otherwise indicates—

“**Act**” means the Financial Markets Control Act, 1989 (Act No. 55 of 1989);

“**administration**” includes any act performed by a financial instrument portfolio manager, or a person acting on his behalf, in connection with—

(a) the buying, selling or holding of instruments on behalf of a client; or
