Kragtens artikel 12 van die Wysigingswet op die Grondwet, 1993 (Wet No 82 van 1993), bepaal ek 1 Julie 1993 as die datum waarop genoemde Wet in werking tree.

**PROCLAMATION**

**No. 56, 1993****1 July 1993****CONSTITUTION AMENDMENT ACT, 1993**  
(ACT NO 82 OF 1993)

In terms of section 9 of the Constitution Amendment Act, 1993 (Act No 82 of 1993) and notwithstanding the provisions of the Members of Parliament and Political Office-bearers Pension Scheme Act, 1984 (Act No 112 of 1984), (hereafter referred to as the Pension Act), I hereby determine that—

- (a) for the purposes of paragraphs (b) and (d) of this proclamation “pensionable service” means actual pensionable service together with added pensionable service of six months;
- (b) if a member of the President's Council has five or more years' pensionable service to his credit on the date of the commencement of the Constitution Amendment Act, 1993,—
  - (i) to him there shall be paid a pension in terms of section 8 and, if applicable to him, in terms of section 9 of the Pension Act, with effect from the date which follows on the date of the said commencement; and
  - (ii) to him there shall be paid a gratuity in terms of section 11 of the Pension Act;
- (c) for the purposes of subparagraphs (i) and (ii) of paragraph (b)—
  - (i) the said extended pensionable service shall be the pensionable service for the purposes of paragraph (i) of the formula referred to in section 8(1) of the Pension Act and paragraph (i) of the formula referred to in section 11(1) of the said Act;
  - (ii) in the case of a member referred to in sections 9(1) and 11(2) of the Pension Act, the period contemplated in paragraph (i) of the formula referred to in section 9(1) and the period contemplated in paragraph (a) of the formula referred to in section 11(2) shall be extended by the period referred to in paragraph (a);
- (d) to a member of the President's Council who has less than five years' pensionable service to his credit on the date of the said commencement, there shall be paid a gratuity in terms of section 11(1) of the Pension Act, instead of an amount in terms of section 13 of that Act;
- (e) the provisions of sections 6 and 12 of the Pension Act shall apply *mutatis mutandis* in the application of the preceding paragraphs;

(WET NO 82 VAN 1993)

Kragtens artikel 9 van die Wysigingswet op die Grondwet, 1993 (Wet No 82 van 1993), bepaal ek, ondanks die bepalings van die Wet op die Pensioenskema vir Parlementslede en Politieke Ampsbekleërs, 1984 (Wet No 112 van 1984), (hieronder die Pensioenwet genoem) dat—

- (a) vir doeleindes van paragrawe (b) en (d) van hierdie proklamasie “pensioengewende diens” werklike pensioengewende diens tesame met toegevoegde pensioengewende diens van ses maande beteken;
- (b) indien ’n lid van die Presidentsraad op die datum van inwerkingtreding van die Wysigingswet op die Grondwet, 1993, vyf jaar of langer pensioengewende diens tot sy krediet het,—
  - (i) aan hom, met ingang van die datum wat volg op die datum van genoemde inwerkingtreding, ’n pensioen ingevolge artikel 8 en, indien van toepassing op hom, ingevolge artikel 9 van die Pensioenwet betaal word; en
  - (ii) aan hom ’n gratifikasie ingevolge artikel 11 van die Pensioenwet betaal word;
- (c) vir die doeleindes van subparagraphs (i) en (ii) van paragraaf (b)—
  - (i) bedoelde verlengde pensioengewende diens die pensioengewende diens is vir die doeleindes van paragraaf (i) van die formule vermeld in artikel 8(1) van die Pensioenwet en paragraaf (i) van die formule vermeld in artikel 11(1) van genoemde Wet;
  - (ii) in die geval van ’n lid bedoel in artikels 9(1) en 11(2) van die Pensioenwet, die tydperk bedoel in paragraaf (i) van die formule vermeld in artikel 9(1) en die tydperk bedoel in paragraaf (a) van die formule vermeld in artikel 11(2) verleng word met die tydperk vermeld in paragraaf (a);
- (d) aan ’n lid van die Presidentsraad wat op die datum van genoemde inwerkingtreding minder as vyf jaar pensioengewende diens tot sy krediet het, ’n gratifikasie ingevolge artikel 11(1) van die Pensioenwet, in plaas van ’n bedrag ingevolge artikel 13 van dié Wet, betaal word;
- (e) die bepalings van artikels 6 en 12 van die Pensioenwet *mutatis mutandis* van toepassing is by die toepassing van die voorafgaande paragrawe;
