ACT

**To appropriate amounts of money for the requirements of the Administration:
House of Representatives in the financial year ending 31 March 1994.**

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

Appropriation of amounts of money for requirements of Administration: House of Representatives

1. Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives in the financial year ending 31 March 1994, the amounts of money shown in column 1 of the Schedule, with which the Revenue Account: House of Representatives shall be charged. 5
