AMENDMENT OF RULES

It is hereby notified that the following amendments to the Rules framed in terms of section 74 (1) of Act No. 53 of 1979 and which have been approved by the Chief Justice of South Africa in consultation with the Judge President of the Transvaal in terms of section 74 (2) of Act No. 53 of 1979, are promulgated by the Council of the Law Society of the Transvaal:

1. Amendment of rule 12.2

Delete the following wording:

"[, with or without modification,]".

2. Rule 80.4.4

The proviso shall be amended as follows (*the underlined portion is new*):

"... provided that, where the decision is that of the committee, either the member or such person, if he objects to the decision of the committee, shall within 10 days after the date of the allocatur, or such longer period allowed by the Council on sound reasons, and before taking any other steps, submit that decision to the council with a view to having the decision amended or withdrawn, stating in his submission, which shall be in writing, the respects in which he takes objection to the decision and the grounds upon which he claims that amendment or withdrawal of the decision is justified.";

and the addition of a subparagraph:

"Unless the other party agrees to an extension of the period contemplated in rule 80.4.4, an application for condonation of the belated lodgement of the objection, together with sound reasons for the delay, shall be submitted to the council.".

DIE PROKUREURSORDE VAN TRANSVAAL

WYSIGING VAN REËLS

Hiermee word kennis gegee dat die volgende wysiging in die Reëls opgestel kragtens artikel 74 (1) van Wet No. 53 van 1979 en wat deur die Hoofregter van Suid-Afrika in ooreenstemming met die Regter-president van Transvaal goedgekeur is ingevolge artikel 74 (2) van Wet No. 53 van 1979, deur die Raad van die Prokureursorde van Transvaal uitgevaardig word:

1. Wysiging van reël 12.2

Skrap die volgende bewoording:

"[, met of sonder wysiging,]".

2. Reël 80.4.4

Die voorbehoudsbepaling moet soos volg gewysig word (*die onderstreepte gedeelte is nuut*):

"... met dien verstande dat indien die beslissing deur 'n komitee geneem is, of die lid of sodanige persoon wat beswaar teen die beslissing van die komitee het, binne 10 dae na datum van die allocatur, of die langer tydperk wat op goeie gronde deur die Raad toegelaat mag word, en voordat hy enige ander stap doen, daardie beslissing aan die raad moet voorlê met die doel om die beslissing te laat wysig of intrek, terwyl hy in sy voorlegging skriftelik aanvoer in welke opsigte hy beswaar teen die beslissing aanteken en die gronde waarop hy beweer die wysiging of intrekking van die beslissing geregverdig is.";

en die byvoeging van 'n subparagraaf:

"Tensy die ander party tot 'n verlenging van die tydperk in reël 80.4.4 bedoel toestem, moet 'n aansoek om kondonاسie vir die laat-indiening van die beswaar, tesame met gegronde redes vir die versuim, by die raad ingedien word.".
