

#### **BUILDING SOCIETIES SECOND AMENDMENT DECREE, 1993**

#### DECREE

To amend the Mutual Building Societies Act, 1965.

[English text signed by the Deputy Chairman of the Council of State. Assented to on 15 September 1993.]

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

- 1. Amendment of section 1 of Act 24 of 1965, as amended by section 1 of Act 64 of 1968, section 5 of Act 67 of 1973, section 54 of Act 101 of 1976, section 22 of Act 80 of 1978, section 50 of Act 99 of 1980 and section 1 of Decree 15 of 1993. Section 1 of the Mutual Building Societies Act, 1965 is hereby amended by the substitution for the definition of "Republic" of the following definition:
  - "'Republic' means the Republic of Ciskei and, for the purposes of sections 20(1), 55(14)(b) and 65A(2)(b), includes the Republic of South Africa and any territory which previously formed part of that state.".
- Short title. This decree shall be called the Building Societies Second Amendment Decree, 1993.
