UNEMPLOYMENT INSURANCE ACT, 1966

EXTENSION OF THE PERIOD OF EXEMPTION GRANTED TO EMPLOYERS IN AGRICULTURE IN TERMS OF SECTION 17 (1) OF THE UNEMPLOYMENT INSURANCE AMENDMENT ACT, 1992 (ACT No. 130 OF 1992)

1. Representations have been received that the period of grace during which employers in agriculture must register with the Unemployment Insurance Fund, should be extended further.
2. In the light of the above, I, Leon Wessels, Minister of Manpower, in terms of section 17 (2) of the Unemployment Insurance Amendment Act (Act No. 130 of 1992), extend the period as stipulated in section 17 (1) of the latter Amendment Act, further until **31 March 1994**.
