A Committee of Publications referred to in section 4 of the Publications Act, 1974 (the Act), which decided in terms of section 11 of the Act that the undermentioned publication is not undesirable within the meaning of section 47 (2) of the Act, has in terms of section 9 (1) of the Act declared that every subsequent edition of the said publication will be subject to the following conditions:

That the publication may not knowingly be sold, hired or lent out by lending libraries to persons under the age of 18 years; and

dat die publikasie slegs in 'n geseëde plastiek-omhulsel vir die doeleindes van verspreiding uitgestal en versprei mag word.

that the publication for purposes of distribution may only be displayed and distributed in a sealed plastic wrapping.
