- (c) 'n staat van opbetaalde lidmaatskap van sodanige organisasie soos aan die einde van November 1993 en die wyse waarop dit bepaal is, bv. 'n geouditeerde staat.

#### CALLING OF A FOUNDING MEETING OF THE EDUCATION LABOUR RELATIONS COUNCIL

I, Rolf Heinrich Stumpf, Interim Chairman of the Education Labour Relations Council, hereby give notice in terms of section 21 (2) of the Education Labour Relations Act, 1993 (Act No. 146 of 1993), that the founding meeting of the Education Labour Relations Council will be held on 1 March 1994 at the Conference Centre, Human Sciences Research Council Building, 134 Pretorius Street, PRETORIA.

All employer organisations and employee organisations are called upon to attend the founding meeting and to furnish the Interim Secretary, Mr R. V. Venter, at the Department of National Education, Private Bag X122, PRETORIA, 0001, not less than seven days before the date set for the founding meeting, with the following information:

- (a) The fullname of the employer organisation or employee organisation, as the case may be, the full postal address and the full street address of such organisation;
- (b) the full names and particulars of office of not less than two but not more than four delegates of such employer organisation or employee organisation who shall represent such organisation at the founding meeting; and
- (c) a statement of the paid-up membership of such organisation as at the end of November 1993 and the method used to arrive at this figure, e.g. an audited statement.
