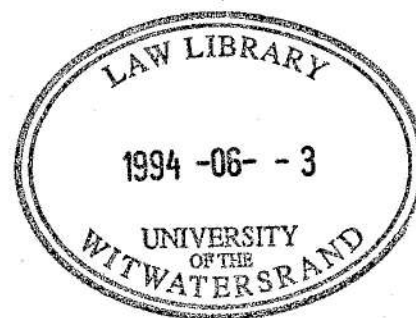

## GOVERNMENT NOTICE No. 18 OF 1994

The following Government Notice is published for general information:

**ADMINISTRATIVE AUTHORITIES ACT, 1984 (ACT 37 OF 1984): DISESTABLISHMENT OF THEMBU COMMUNITY AUTHORITY AND RE-ESTABLISHMENT OF THEMBU TRIBAL AUTHORITY IN THE DISTRICT OF HEWU.**

Under and by virtue of the powers and authorities vested in me by sections 2, 3 and 58 of the Administrative Authorities Act, 1984, I, Oupa Joshua Gqozo, Minister of Planning and Rural affairs, do hereby -

- (a) disestablish the Thembu Community Authority in the district of Hewu;
- (b) re-establish the Thembu Tribal Authority in the said district;
- (c) amend Schedule 1 of the said Administrative Authorities Act, 1984 in the manner set out in Annexure 1; and  
amend Proclamation 1 of 1992 in accordance with the provisos of Annexure 2.

### Annexure 1

Schedule 1 of the Administrative Authorities Act, 1984 amended by the substitution for item 1.2 of the following item:

"Item 1.2 The Tribal Authority - From 6 to 12 councillors.

Area of tribe - The area in the district of Hewu bounded as follows:

"From the beacon common to the Farms Bushman's Krantz, Hopewell and High Meadow generally westwards along the boundary of the farm Bushman's Krantz to the point where it meets the Oxkraal river; thence up the middle of the Oxkraal river and along the western boundaries of the farms Bushman's Krantz, Pevet, Bushby Park, Yonda, Bold's Point, Price's Dale and Oxton to the northernmost beacon of the farm Oxton; thence generally south-eastwards along the boundaries of the farms Oxton and Haytor to the southernmost beacon of the farm Haytor; thence generally westwards along the boundaries of the farms Haytor, Price's Dale, Bold's Point, Bushby Park and Bushman's Krantz to the point of commencement."

### Annexure 2
