NOTICE OF THE PRESIDENT OF THE REPUBLIC
OF SOUTH AFRICA

NOTICE OF INDEMNITY UNDER THE INDEMNITY
ACT, 1990 (ACT NO. 35 OF 1990)

Under the powers vested in me by section 2 (1) of
the Indemnity Act, 1990 (Act No. 35 of 1990), I hereby
grant to any person—

- (i) who before 6 December 1993 was found in pos-
session of any firearm, ammunition, explosive
or explosive device in contravention of the provi-
sions of any law that regulates the possession of
such firearm, ammunition, explosive or explo-
sive device; and
- (ii) who possessed such firearm, ammunition,
explosive or explosive device in order to defend
a community or any part thereof,

indemnity in respect of such possession.

One thousand Nine hundred and Ninety-four.
