The Independent Broadcasting Authority gives notice under section 52 (2) (a) of the Independent Broadcasting Authority Act, Act No. 153 of 1993, that an application has been received in terms of section 52 (1) (c) for an amendment to the Public Television Broadcasting Licence of the SOUTH AFRICAN BROADCASTING CORPORATION as set out in the Schedule.

The application and any written representations received pursuant thereto are open for inspection by interested parties during the normal office hours of the Authority and any oral representations made in relation to the applications shall be made in public.

Interested parties are invited to submit written representations in relation to the application to the Licensing Department of the Authority at Khasho House, 26 Baker Street, Rosebank, Johannesburg OR Private Bag X31, Parklands, 2121, OR by Fax No. (011) 447-6188/9 within 21 days of the date of publication of this notice. Persons who submit representation in terms hereof shall indicate whether they require any opportunity to make oral representations to the Authority.
