NOTICE OF INTENTION TO DECLARE A PORTION OF THE N4 BETWEEN THE GAUTENG/MPUMALANGA BORDER AND THE MPUMALANGA/MOCAMBIQUE BORDER (KOMATIPOORT) TO BE A TOLL ROAD

1. The South African Roads Board hereby notifies all interested parties of its intention to declare under section 9 of the National Roads Act, 1971 (Act No. 54 of 1971), the following portions of the National Road N4 to be a toll road:

Sections 3, 4, 5, 5X, 6X, 7X and 8X, as declared by Government Notices Nos. 116 of 1985, 190 of 1985, 296 of 1972, 358 of 1977, 160 of 1986, 186 of 1987, 149 of 1981 (as amended by Government Notices Nos. 188 of 1985, 455 of 1987 and 2014 of 1990), 188 of 1985, 2014 of 1990 and 2446 of 1992, commencing at the Provincial boundary which coincides with the boundary between the farms Spitskop 533 JR (in Bronkhorstspuit District) and Eenzaamheid 534 JR (in Witbank District), and ending on the farm Customs Site Reserve 183 JU at the entrance of the customs terrain.

2. In terms of section 9 (3) (c) of the National Roads Act, 1971, all interested parties are hereby invited to make written representations, within 30 days from the date of this notice, to the South African Roads Board on the proposed declaration of the said portion of the national road as a toll road. The representations in question may be addressed to the Chairman of the Board at P.O. Box 415, Pretoria, 0001.

3. In terms of section 9 (3) (d) of the National Roads Act, 1971, a schematic indication of the approximate position of the proposed toll gates is given in the Schedule hereto.

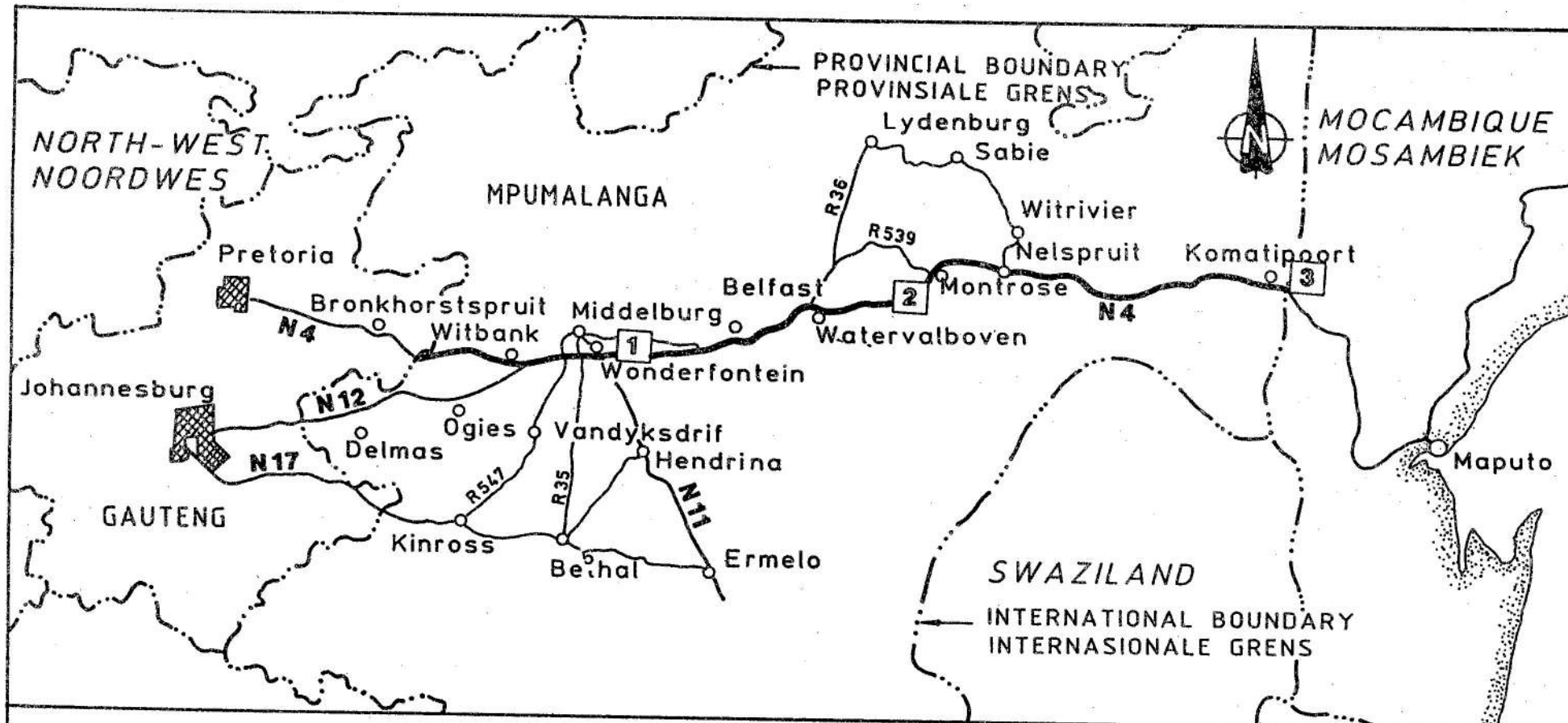

Seksies 3, 4, 5, 5X, 6X, 7X en 8X, soos verklaar by Goewermentskennisgewings Nos. 116 van 1985, 190 van 1985, 296 van 1972, 358 van 1977, 160 van 1986, 186 van 1987, 149 van 1981 (soos gewysig deur Goewermentskennisgewings Nos 188 van 1985, 455 van 1987 en 2014 van 1990), 188 van 1985, 2014 van 1990 en 2446 van 1992, wat begin by die Provinsiale Grens wat saamval met die grens tussen die plase Spitskop 533 JR (in die distrik Bronkhorst-spruit) en Eenzaamheid 534 JR (in distrik Witbank), en eindig op die plaas Customs Site Reserve 183 JU by die ingang van die doeaneterrein.

2. Ingevolge artikel 9 (3) (c) van die Wet op Nasionale Paaie, 1971, word alle belanghebbendes uitgenooi om binne 30 dae na datum van hierdie kennisgewing skriftelike versoë tot die Suid-Afrikaanse Padraad oor die voorgenome verklaring van die vermelde gedeelte van die nasionale pad tot 'n tolpad, te rig.
