CALL FOR NOMINATIONS OF PERSONS TO PARTICIPATE IN DEVELOPMENT WORK RELATING TO THE DEVELOPMENT OF THE NATIONAL FRAMEWORK AND A STRATEGIC PLAN FOR TECHNOLOGY ENHANCED LEARNING

I, Sibusiso Mandlenkosi Emmanuel Bengu, Minister of Education, hereby call for applications by or nominations of suitably qualified and experienced persons in the field of education to serve on an Investigating Committee which will be responsible for development of policy proposals to the envisaged Technology Enhanced Learning. The Investigating Committee will be responsible for the formulation of proposals which will serve as guidelines for further debate and development of the following:

- A policy and plan for the infrastructure necessary to support Technology Enhanced Learning.
- A policy on and identification and adoption of standards and protocols to underpin Technology Enhanced Learning.
- A policy on strategies on partnerships between the education sector and other key stakeholders in contributions to Technology Enhanced Learning.
- A framework for evaluating major proposals for Technology Enhanced Learning as part of a co-ordinated and systematic tendering process.

This could be done by—

- ▶ ensuring that the programme areas cover a broad range of educational sectors/areas as well as the information/communication needs of other sectors;
- ▶ identifying all appropriate stakeholders and ensuring that all are consulted, including the public sector, the private sector and, where appropriate, the international sector;
- ▶ focussing on the following areas:
 - ▷ technology infrastructure
 - ▷ user consultation and support
 - ▷ development of learning materials
 - ▷ related human resources development needs and facilities
- ▶ including an assessment of the appropriateness and relevance of different types of learning resources, for example, the difference between foreign and locally produced materials.

The Investigation Committee will start its work on 1 March 1996 and submit its final report in June 1996.

NOMINASIES VERLANG VAN PERSONE OM DEEL TE NEEM AAN DIE ONTWIKKELINGSWERK MET BETREKKING TOT DIE ONTWIKKELING VAN DIE NASIONALE RAAMWERK EN 'N STRATEGIESE PLAN VIR TEGNOLOGIEVERRYKTE LEER

Ek, Sibusiso Mandlenkosi Emmanuel Bengu, Minister van Onderwys, verlang aansoeke of nominasies van persone wat na behore gekwalifiseer en ervare is op onderwysgebied om te dien in 'n Ondersekkomitee wat vir die ontwikkeling van beleidsvoorstelle tot die beoogde Tegnologieverrykte Leer verantwoordelik sal wees. Die Ondersekkomitee sal verantwoordelik wees vir die formulering van voorstelle wat as riglyne sal dien vir verdere bespreking en beleidsontwikkeling wat op die volgende betrekking het:

- Beleid en planne vir die infrastruktuur wat benodig word vir die ondersteuning van Tegnologieverrykte Leer.
- Beleid oor en die identifikasie en aanvaarding van standarde en protokol vir die ondersteuning van Tegnologieverrykte Leer.
- Beleid oor strategie en vennootskappe tussen die onderwyssektor en ander sleutelrolspelers wat bydra tot Tegnologieverrykte Leer.
- 'n Raamwerk vir die evaluering van belangrike voorstelle vir Tegnologieverrykte Leer as deel van 'n gekoördineerde en sistematiese tenderproses.

Dit kan gedoen word deur—

- ▶ te verseker dat die programareas sowel 'n wye reeks sektore/areas as die inligting/kommunikasiebehoeftes van ander sektore sal dek;
- ▶ alle geskikte belanghebbendes te identifiseer en te verseker dat almal geraadpleeg word, insluitend die staatsdiens, privaatsektor, en, waar nodig, die internasionale gemeenskap;
- ▶ op die volgende areas te fokus:
 - ▷ tegnologie-infrastrukture
 - ▷ gebruikerraadpleging en -ondersteuning
 - ▷ ontwikkeling van leerstof
 - ▷ aanverwante menslike hulpbronontwikkelingsbehoeftes en fasiliteite
- ▶ 'n evaluering te doen van die geskiktheid en relevansie van verskillende tipes leerbronne, byvoorbeeld, die verskil tussen oorsese en plaaslik vervaardigde materiale.

Die Ondersekkomitee sal op 1 Maart 1996 met sy werksaamhede begin en die finale verslag in Junie 1996 voorlê.
