EMPLOYEES TAX DEDUCTION TABLES

In terms of paragraph 9 (2) of the Fourth Schedule to the Income Tax Act, 1962 (Act No. 58 of 1962), it is hereby announced:

1. The separate deduction tables which are known as the IRP10B, IRP10C and IRP10T Tax Deduction Tables, Volume 36, and which came into force from 1 June 1995 in respect of the former Republics of Bophuthatswana, Ciskei and Transkei, respectively, are withdrawn with effect from 1 March 1996.
2. Volume 36 of the IRP10 Tax Deduction Tables will come into force in the former Republics of Bophuthatswana, Ciskei and Transkei with effect from 1 March 1996.
